**EDITORIAL POLICY**

*JMBA* is an international journal, publishing original research on all aspects of marine biology. It includes pioneering work taking place today on major issues concerning marine organisms and their environment. Subjects covered include: ecological surveys and population studies of marine communities; physiology and experimental biology; taxonomy, morphology and life history of marine animals and plants; and chemical and physical oceanographic work.

Papers describing work involving experimental procedures on living animals will be published only if they comply with the legal requirements of the UK Home Office. In the case of species not covered by the current law, papers will be published only if it is judged that the experiments have been conducted in a humane manner and adequate precautions taken to minimize stress.
