# Rural Local Government in Sweden, Italy and India

This comparative study was initiated by UNESCO under contract with the International Political Science Association. When selecting the reporting team emphasis was placed on finding competent scholars, familiar with the local government of their own countries, and the final comparative report was entrusted to Harold Zink, Professor of Political Science in Ohio State University.

The topics discussed are the scope and current status of rural local government, its historical development, legal status, machinery, activities, finance and intergovernmental relations. In each chapter there is a passage on each country, followed by a conclusion comparing the three.

The reporters have put in a year's hard work, and the unity of the book speaks very well for the co-ordinating influence of Professor Zink.

The purpose of the now well-established *British Commonwealth Series* is to examine and explain the structure and development of the constitutional laws of the Commonwealth. This series is particularly valuable today, when the Commonwealth relationship is visibly entering a new phase.

The Pakistan Constitution was only promulgated in February 1956, and this is in effect the first comprehensive jurisprudential account of it. Part I includes the Islamic conception of the state, the historical development of the constitutional and administrative machinery of British India up to 1947, the main constitutional changes of 1956, the powers of the executives and legislatures, the powers and independence of the judiciary, fundamental rights and directive principles. Part II deals with the laws—including legislation since independence.

Professor Gledhill's readable and interesting work on the Indian Constitution was so popular that it was soon reprinted. His new book on Pakistan is equally good.
