A Report on the Congressional Fellowship Program, 1993-94 and 1994-95

The Congressional Fellowship Program is a professional level internship that gives academics, journalists, federal executives, and other professionals an opportunity to work on the staffs of senators, representatives, and congressional committees. Its goals are:

- to improve the quality of scholarship and teaching on Congress and American national politics;
- to enhance public understanding of Congress and policymaking; and
- to provide professionals from several fields with practical experience in Congress and insight into the legislative process.

Since 1953, the first year of the Program, there have been a total of 1,569 Fellows, including 242 political scientists, 200 journalists, 767 federal executives, 308 medical faculty, and others.

Although the first class of Fellows had only six members, in recent years the Program has grown to include up to 50 Fellows each year. The political science and journalism Fellows are selected in nationwide competitions. Political science applicants must have completed their doctorates within the last fifteen years or be near completion, and reporters must have a bachelor's degree and between two and ten years of professional experience in newspaper, magazine, television, or radio reporting. Criteria for selection are quality training, demonstrated competence, maturity and responsibility, relevance of fellowship experience to career goals, and potential for professional advancement.

While the political scientists and journalists remain the core of the program and are supported by the APSA through contributions from corporations and foundations, the majority of each year's class of Fellows participates in the program through affiliate arrangements, including:

- federal executives (Grades 13-16) supported by agency training funds;
- Asian Fellows supported by the Asia Foundation;
- Health Policy Fellows, including

- German Fellows supported by The German Marshall Fund;
- Carl Albert Fellows supported by the Carl Albert Center at the University of Oklahoma; and
- a French Fellow supported by the Fondation Franco-Americaine in Paris

In recent years, those who have funded political scientists and journalists include the Knight Foundation, Knight Ridder, Incorporated, the New York Times Company Foundation, MCI Communications Corporation, International Business Machines, the Poynter Fund and Congressional Quarterly Inc.

The Walter and Phyllis Shorenstein family has provided funding to endow a Fellowship in the name of their daughter, Joan Shorenstein Barone. Joan was a well-known and highly respected producer for CBS News who died in 1985 at a tragically early age. The Joan Shorenstein Barone Fellowship is awarded annually to a broadcast journalist of special merit, and was given for the first time to a 1986–87 Fellow, Jean Powell, who is now anchor, producer

and reporter, for (ABC affiliate) KEZI-TV, Eugene, Oregon. Douglas Johnson, Senior Producer/Acting Managing Editor, Michigan Public Radio Network, has been named the 1994–95 Joan Shorenstein Barone Congressional Fellow.

From 1985-86 through 1992-93 the Poynter Fund, charitable foundation of the Times Publishing Company, contributed major support for one promising print journalist per year. The 1992-93 Poynter Fellow was Maureen Groppe, staff writer for the South Bend (Indiana) Tribune. Congressional Quarterly Inc., whose publications fall under the aegis of the Times Publishing Company, funded the 1993-94 Poynter Fellow and is funding 1994-95 Poynter Fellow Lori Nitschke, City Government and Local Politics Reporter, Grand Forks Herald, Grand Forks, North Dakota.

In early 1991, MCI Communications Corporation awarded the Association a generous endowment to support the Congressional Fellowship Program in perpetuity. In addition to funding six political scientists and journalists, the gift provides financial support for up to two scholars from any field or discipline, or journalists, all of whom must have an analytical interest in public policy and in telecommunications. The **APSA-MCI Communications Fellows** are chosen annually through rigorous national competition. The first APSA-MCI Communications Congressional Fellow was Shannon LeHere Fioravanti (1992-93 class), now Manager, Corporate Relations, Bell Atlantic Corporation. Winners of 1994-95 APSA-MCI Communcations Congressional Fellowships are David Eskola, Television Columnist, The Greenville News, Greenville, SC, and Stephen McDowell, Sessional Lecturer, Carleton University, Ottawa, Canada.

The Fellowship Program commences in early November with an orientation period that includes meetings and seminars with members of Congress, congressional staffs, political scientists, journalists, lobbyists, government administrators, and others on a wide range of topics relating to Congress and national politics. During this time Fellows also begin exploring possibilities for assignments in congressional offices. These negotiations are conducted by the Fellows themselves, and their placements are determined by the Fellows and the offices in which they will work. Fellows begin work in House or Senate offices in early December, and some serve in initial assignments for about four and one-half months. In April Fellows are encouraged to seek new assignments on the other side of
