This book, written from perspectives of identification with the larger community of mankind and addressed to all who share such identification, is designed as a clarification of the common interest in the continued maintenance of an international law of the sea which rejects all claims of special interest and weighs every decision most heavily in favor of inclusive rather than exclusive, interests. The book is based on a two-fold conviction: first, that all peoples can benefit most from a public order of the oceans which secures for all the highest possible degree of shared access to ocean resources and of shared competence over ocean activities and, secondly, that a public order adequate to such can only be established and maintained by peoples' effective recognition and understanding of their common interests, with continuous reassessment in the context of the development and change characteristic of the contemporary world.

This is the second volume in *The New Haven Studies in International Law and World Public Order*, a series which brings together and continues the monographs prepared at the Yale Law School under the supervision of Myres S. McDougal and Harold D. Lasswell. This series will be of interest to scholars, practising international lawyers, government officials and corporate personnel, as well as to students of international relations and political science.

Edited by a law professor and a political scientist, this book consists of a collection of essays on abortion and protection of the human fetus as discussed by authors native to each of the countries included. An introductory chapter deals with the international legal aspects of the subject followed by separate chapters describing the social, political, and legal dimensions in Austria, Federal Republic of Germany, France, Sweden, England, Ireland, the USA, and the countries of Eastern Europe (including the USSR). By the use of a uniform outline the description in each chapter allows readers to make comparative assessments.

The articles selected for publication in this volume were chosen from among those presented at the Third World Congress for Soviet and East European Studies held in Washington, D.C., from 30 October to 4 November 1985. The Congress, which was sponsored by the International Committee for Soviet and East European Studies and the American Association for the Advancement of Slavic Studies, attracted over 3000 scholars from forty-one countries, a figure which reflects the present revival of Slavic Studies throughout the World.

Soviet law had emerged as the most important instrument of reform in the *perestroika* campaign initiated by General Secretary Gorbachev, himself a lawyer. In this volume leading Western experts on Soviet law highlight a number of themes which have acquired special significance at the present time. They range from historical investigations of law during the Stalin era to studies on the human rights situation now; domestic questions, such as housing and criminal law, are covered, as are various international matters.
