

Marie Anchordoguy, associate professor and chair of the Japan Studies Program in the Henry M. Jackson School of International Studies at the University of Washington, specializes in the political economy of Japan. She has published numerous articles, including "Japanese-American Trade Conflict and Supercomputers" in Political Science Quarterly (Spring 1994), "Japan at a Technological Crossroads: Does Change Support Convergence?" in Journal of Japanese Studies (Summer 1997), and "Japan's Software Industry, A Failure of Institutions?" in Research Policy (2000). She has also written a book, Computers, Inc.: Japan's Challenge to IBM (1989). She is currently researching the state's role in Japan's telecommunications, computer hardware, computer software, semiconductor, and consumer electronics industries.

Mansel G. Blackford works in the fields of western American history and business history at The Ohio State University. He is the author of several books, including The Rise of Modern Business in Great Britain, the United States, and Japan (1988; second edition, 1998), A History of Small Business in America (1991), and, with coauthor Austin Kerr, BFGoodrich: Tradition and Transformation, 1870–1995 (1996). Most recently, he has published Fragile Paradise: The Impact of Tourism on Maui, 1959–2000 (2001).

Pascal Griset is professor of history at the Sorbonne (Paris) and director of the Centre de Recherche en Histoire de l'Innovation. He is the author of Les revolutions de la communication XIXe–XXe siecle (1991) and Entreprise, Technologie et Souverainte: Les telecommunications transatlantiques de la France (XIXe–XXe siècles) (1996). With Alain Beltran, he has written Histoire des techniques au XIXe et XXe siècles (1990) and L'économie française, 1914–1945 (1994), and, with Eric Bussiere, Christophe Bouneau, and Jean-Pierre Williot, Industrialisation et sociétés en Europe occidentale 1880–1970 (1998). He is currently studying French consumer culture.

Daniel R. Headrick is professor of social science and history at Roosevelt University in Chicago. He is the author of *The Tools of*

Empire: Technology and European Imperialism in the Nineteenth Century (1981), The Tentacles of Progress: Technology Transfer in the Age of Imperialism, 1850–1940 (1988), The Invisible Weapon: Telecommunications and International Politics, 1851–1945 (1991), When Information Came of Age: Technologies of Knowledge in the Age of Reason and Revolution, 1700–1850 (2000), and numerous articles. He is currently studying the evolution of information systems.

Thomas Heinrich is assistant professor of business and industrial history at Baruch College, New York. His Ships for the Seven Seas: Philadelphia Shipbuilding in the Age of Industrial Capitalism was published by Johns Hopkins University Press in 1997. He is currently completing a book on the Kimberly-Clark Corporation and the introduction of consumer nondurables in the American paper industry. Heinrich is also working on the recent history of military contracting in Silicon Valley.
