Since 2010, the journal has been published on behalf of its owner by the London Mathematical Society (LMS). The LMS celebrated its 150th anniversary in 2015; it is the major British learned Society for mathematics and publishes twelve other journals, five of which are in collaboration with other learned societies. Cambridge University Press prints and distributes *Mathematika* under agreement with the London Mathematical Society.

*Mathematika* publishes both pure and applied mathematical articles of the highest quality. The traditional emphasis has been towards the purer side of mathematics but applied mathematics and articles addressing both aspects are equally welcome.
