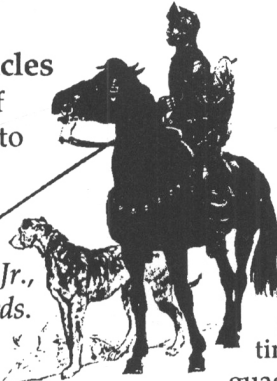

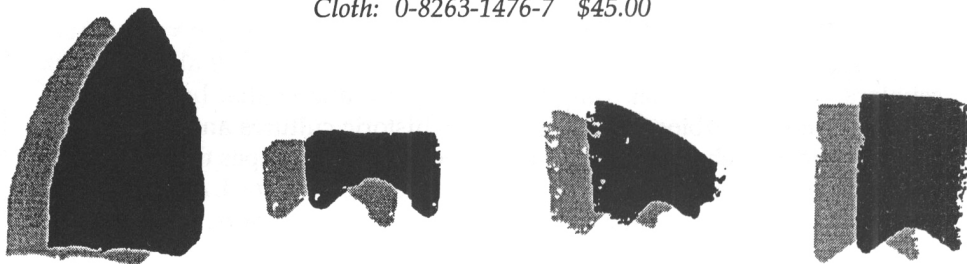

CALL FOR SUBMISSIONS

The privilege of participating in the annual meeting as a presenter, organizer, chair, or discussant is restricted to paid-up members. However, under extraordinary circumstances, representatives of other disciplines, or archaeologists who are not North American residents, may request a waiver of the membership requirement from the SAA Office. Please note that all requests for space for allied meetings should be made in writing and sent to the SAA Office no later than *September 23, 1994*.

Society policy states that a person may not be the first author of more than one paper, although that person may, at the same meeting, chair a session or serve as junior author of a paper presented by someone else or as a discussant. However, no paper should list more than five authors, and no individual may have more than three roles (author, organizer, chair, or discussant) in the meeting. Under extraordinary circumstances exceptions to these policies may be granted by the Program Chair.

Complete symposia proposals (with abstracts of papers), abstracts of contributed papers, abstracts of research reports, and abstracts for poster sessions must reach the SAA Office no later than *September 23, 1994*. *All proposals and abstracts must be submitted on appropriate SAA forms*, which are mailed to all SAA members. Please submit all materials in English.

The Participant Information Form is in two parts: Page one (Submission Form) and page two (Abstract Form). Copies of the Participant Information Form must be submitted by all participants, including symposia organizers, chairs, and discussants, as well as all senior authors of symposia papers, contributed papers, research reports, and posters. In case of coauthorship of papers, *only the senior author* should submit a Participant Information Form containing the information on all of the associated authors.

Because it is no longer possible to accommodate all individuals wishing to make oral presentations at the annual meeting, the Program Committee will evaluate each submission for professionalism, timeliness of receipt, substance of contribution, and redundancy with other submissions. Poster Sessions are especially encouraged and are particularly effective for presentations involving mapping, remote sensing, and various quantitative methods. The Program Committee may request that individual papers or entire symposia be converted to poster format. Symposia organizers and first authors of presentations not in symposia will be notified of the Program Committee's decision to accept or decline the submission by January 16, 1995. Abstracts of all papers, research reports, and posters accepted for presentation will be published in a separate *Abstracts* volume available at the annual meeting.

SYMPOSIUM—A symposium consists of a group of papers on a common theme. Symposia are limited to 4 hours or less. The symposium topic and the individual papers within it will be reviewed. Changes, such as consolidation of two symposia or changes in the individual papers, may be recommended. Symposia organizers should contact the *SAA office* no later than *June 16, 1994* in order that the Guidelines for Symposium Organizers and a special symposium form can be sent to them. Complete symposia proposals must be submitted as a package to the *SAA Office* by the symposium organizer(s) and must be received by *September 23, 1994*.

The package must include four (4) copies of the Symposium Proposal Form and one (1) copy of the Participant Information Form for each senior author, discussant, chair, and organizer (whether or not the organizer is chairing the symposium). The package must also include the Participant Registration Form and fee.

CONTRIBUTED PAPERS (20 minutes)—Contributed papers are distinguished from Research Reports in that they generalize, synthesize, or compare and are addressed to problems of theory, method, culture history, or culture process. Contributed papers must follow the same format as the symposia papers, and each proposed presentation must include one (1) copy of the Submission Form and four (4) copies of the Abstract Form. Participant Registration Form and fee must be included.

RESEARCH REPORTS (10 minutes)—A research report is a presentation that describes the results of a recent field or laboratory research project. Each proposed presentation must include one (1) copy of the Submission Form and four (4) copies of the Abstract Form. Participant Registration Form and fee must be included.

POSTER SESSIONS—The poster session is particularly appropriate for research results that can be described graphically. Poster sessions will be listed in the program and will be displayed in prominent locations. Each proposed presentation must include one (1) copy of the Submission Form and four (4) copies of the Abstract Form. Participant Registration Form and fee must be included.

REGISTRATION FEES—All presenters, chairs, and discussants are required to pay the established registration fee for the annual meeting; registration form and fee must accompany all proposals. Under extraordinary circumstances non-North American residents may request waiver of registration fee to present papers or attend meetings. Waiver requests should be sent to the SAA Office. Registration and/or membership fees will be refunded upon written request before the preliminary program goes to press and for any paper that is declined.

ABSTRACTS will be published as a separate volume and will not be included in the registration fee. Participants who wish to receive a copy of the *Abstracts* when they pick up their badge at the meeting should order and prepay for it on their registration form.

NOTICE TO AUTHORS

American Antiquity publishes original papers on the archaeology of the New World, and on archaeological method, theory, and practice worldwide. Authors of papers on Latin American regional topics are encouraged to submit their work to *Latin American Antiquity*. However, papers on Latin American archaeology may be accepted in *American Antiquity* if they address broad methodological, theoretical, or comparative issues. Authors submit manuscripts to the editor for consideration as ARTICLES, REPORTS, COMMENTS, or FORUM essays. REVIEWS, BOOK NOTES, and OBITUARIES are solicited by the respective associate editors. Information regarding CURRENT RESEARCH should be directed to the managing editor or to the assistant editor for the appropriate region.

Authors should submit an original and four copies of their manuscripts, including all figures, tables, references, and notes. Detailed information on policy, style, and technical matters of manuscript preparation is given in the "Editorial Policy, Information for Authors, and Style Guide for *American Antiquity* and *Latin American Antiquity*," which appeared in the October 1992 issue (57[4]:749–770); for additional information, updates, or clarification consult the managing editor.

The editor reserves the right to evaluate manuscripts (with or without peer review) for appropriate subject matter, quality, length, and compliance with the style guide. Manuscripts may be returned to authors if they fail to meet expectations or conform to these guidelines. Manuscripts are evaluated by the editor in consultation with peer referees, or by the associate editors, as appropriate. The editor has the final responsibility for all decisions regarding manuscripts. The review process generally takes a minimum of two to four months. Authors will be notified as soon as a decision is reached to accept (outright or with revisions) or reject a manuscript.
