The range of documents is wide: besides sermons, essays, and speeches, there are two poems, a chapter from a novel, excerpts from a play, a transcript of a public protest meeting, and two segments of testimony given before Congress.

The formation of the first organized feminist movement in the United States—the nineteenth-century woman suffrage movement—is the subject of this thoughtful study. The author argues that woman suffragism deserves a place alongside the black liberation and labor movements as one of the most important democratic reform efforts in American history. Professor DuBois shows how the suffrage movement grew away from the ideological and strategic control of the abolitionists and pursued an independent course.

Letters of a Slave Family
Edited by Randall M. Miller

Unfolded in this extraordinary collection of letters is the story of an American slave family living in two worlds—Liberia and Alabama. Dating from 1834 to 1865, the letters give a rare glimpse into the inner lives of both slaves and freedmen. They reveal the relationship of two generations of the Skipwith family with the planter John Hartwell Cocke, a Jeffersonian liberal who freed some of his slaves and sent others from Bremono, his home in Virginia, to work on a cotton plantation he owned in Alabama.

Lance Banning

This revisionary study offers a convincing new interpretation of Jeffersonian Republican thought in the 1790s. As Bernard Bailyn did for an earlier era, Professor Banning establishes the prevailing state of mind, and views events from that perspective. Based on extensive research in the newspapers and political pamphlets of the decade as well as the public and private writings of party leaders, the book traces the development of party ideology and examines the relationship of ideology to party growth and actions.

Jefferson and the Presidency

Leadership in the Young Republic
Robert M. Johnstone, Jr.

This book focuses on the character of Jefferson's leadership—the dimensions of his task, the nature of his talents, the resources available to him, and the ways in which he understood and used them. Employing role analysis and the bureaucratic bargaining model developed by Richard Neustadt, the author has organized his work around an examination of the three key variables of role, political style, and setting. Professor Johnstone contends that Jefferson's presidency marked the pioneering effort to establish the office as a popular institution.

Like the previous five volumes, volumes six through nine utilize source material gathered from some 15 million documents—many of them declassified especially for this purpose. Covering the years from May, 1945, to February, 1948, the papers show Eisenhower at the apex of his military career, when, as Chief of Staff, he had already begun developing the skills and habits of mind that were to distinguish him as a political leader and statesman during his two terms as President of the United States. The crucial events of this period, which did so much to shape the world as we know it today, as well as the personal history of Dwight David Eisenhower, are here illuminated in four volumes.

M. H. Smith

“Then and there the child Independence was born.” Thus John Adams recalled the Boston courtroom debate on writs of assistance he had attended in February 1761. James Otis’ challenge to this blanket authorization of invasion of private property by customs officers pursuing smuggled merchandise anticipated by years the Fourth Amendment ban on general search warrants. Yet this is the first book-length treatment of that important case.

Mr. Smith has broken much new ground: he uncovers the juridical origins of the writ, and elucidates the basics of customs law. The core of the book is the courtroom arguments themselves and the development of the case.

NOTES FOR CONTRIBUTORS

- 1 All contributions and editorial correspondence should be sent to: The Editor, *Journal of American Studies*, School of English and American Studies, University of East Anglia, Norwich NR4 7TJ, England.
- 2 Articles should generally contain about 5,000 words. Longer or shorter articles, or articles in two or more parts, may be accepted by arrangement with the Editors.
- 3 Submission of an article is taken to imply that it has not previously been published, and is not being considered for publication elsewhere.
- 4 Contributions should be clearly typed in double spacing (including footnotes), preferably on A4 paper, with a wide left-hand margin. Diagrams, maps and illustrations may be included.
- 5 Spelling may conform either to British or American usage, providing it is consistent throughout.
- 6 Footnotes should be used sparingly: in general, to give sources of direct quotations, references to main authorities on disputable questions, and evidence relied on for a new or unusual conclusion. They should be numbered consecutively, and may most conveniently be placed, in double spacing, at the end of the article.
- 7 For guidance on matters of style, contributors should refer either to the *MLA Style Sheet* (2nd ed.), or to the *Journal of American Studies Style Notes*, copies of which may be obtained from the Editors.
- 8 Contributors should keep one copy of the typescript for correcting proofs.
- 9 Notes intended for the Editors or printer should be on a separate sheet.
- 10 First proofs may be read and corrected by contributors provided that they can give the Editor an address through which they can be reached without delay and can guarantee to return the corrected proofs to the Editor, by airmail where necessary, within three days of receiving them.
- 11 Corrections should be kept to an absolute minimum. They should be confined to errors of the typist or printer unless the Editor authorizes otherwise.
- 12 Contributors of articles and review essays receive 25 free offprints. Extra copies may be ordered according to a scale of charges.
- 13 Contributors need not be members of the British Association for American Studies. Unsolicited typescripts can only be returned to overseas contributors who send International Reply Coupons (not postage stamps).
- 14 Contributors of accepted articles will be asked to assign their copyrights, on certain conditions, to Cambridge University Press, to help protect their material, particularly in the USA.
