'A Gift of Hope for Future Generations' is what Kofi Annan, Secretary-General of the United Nations, called the International Criminal Court on the adoption of its Statute in Rome, July 1998. Six months later, on 15 December 1998, a seminar was held in the Netherlands Ministry of Foreign Affairs, which analysed the position of the ICC within the international arena, exploring its relationship to the International Court of Justice, the International Criminal Tribunal for the Former Yugoslavia and the Security Council, as well as its relationship to the host country, the Netherlands.

A number of contributions to the seminar are contained in the present volume. In addition to these contributions, essays are included that reflect on parts of the Statute or on the process by which it was created.

The various contributions are written by eminent international lawyers, several of whom were actively involved in the negotiations leading to the adoption of the Rome Statute. This compilation is dedicated to Adriaan Bos, the Legal Adviser of the Ministry of Foreign Affairs, who was the chairman of all the preparatory meetings leading to the Rome Conference. His opening contribution to the seminar is also included in this volume. The book is divided in two parts, the first part dealing with diverse aspects of the Statute, the second one with the ICC in its perspective.

The Contested Maritime and Territorial Boundaries of Malaysia An International Law Perspective

Malaysia exemplifies boundary problems faced by most countries throughout Southeast Asia. This work studies the origins of Malaysian maritime and territorial disputes. The main text is divided into two parts: The first examines the maritime claims arising from the publication of the Malaysian map issued in 1979. The second analyses five territorial disputes between Malaysia and its neighbours, The Contested Maritime and Territorial Boundaries of Malaysia explores the country's overlapping maritime claims in the Straits of Malacca and Singapore, the Gulf of Thailand, the South China Sea, the Sulu Sea, and the Celebes Sea. A comprehensive examination of Malaysia's territorial disputes with Indonesia, Singapore, Brunei, the Philippines, China, and Taiwan follows, including coverage of the complicated matter of ownership over the Spratty Islands. A detailed look at the historical context demonstrates the longevity and complexity of the legal issues involved in the present disputes. The work scrutinizes the claims made under prevailing international law principles and examines the present level of dispute resolution. The first extensive study of its kind and an important addition to the International Boundary Studies Series, The Contested Maritime and Territorial Boundaries of Malaysia includes a chronological list of the main treaties, legislation, and related documents concerning the disputes discussed; an extensive bibliography of publications regarding the issues raised; and 23 maps, making it the most comprehensive reference work available on this subject. The author has a BA (Hons) in Anthropology, Southeast Asian Studies with Law and a PhD in International Law and has lived for more than a decade in Malaysia.

The Rule of Law in International Affairs International Law at the Fiftieth Anniversary of the United Nations

by lan Brownlie, Chichele Professor of Public International Law, University of Oxford, UK This volume consists of a carefully edited version of the General Course on Public International Law delivered at the Hague Academy of International Law to commemorate the fiftieth anniversary of the foundation of the United Nations. The author brings to them not only his background of academic distinction, but his experience as a practitioner concerned with major international legal issues. The rule of law in international affairs is a question of perennial concern but it is of greater moment these days for a number of reasons. The active agenda of the Security Council and its relative solidarity creates a paradox. Its increased political power is a source of hope but the modalities of the exercise of power present problems of principle and of legal concern. Another area of concern is the International Court, which has had a successful record since the early eighties and provides one of the guarantees of the maintenance of legality. Recent successes of the Court include the effective resolution of the territorial dispute between Chad and Libya. The general level of compliance with its decisions by States is impressive. Yet its success is matched not by encouragement and enhancement of its facilities but by United Nations financial constraints which hinder its work and,

This volume contains the basic documents on the international regulation of doping in sport (non-governmental part). Included are, inter alia, the IOC Medical Code, which is a guiding instrument and model for the international sports world, and the doping regulations of the international Olympic sports federations. Relevant provisions in the Statutes and Constitutions and in the competition regulations of the international Olympic sports organisations have been added in order to complete this collection of basic documents on doping. All texts included are reproduced in the version that was valid at the time of the World Conference on Doping in Sport, 2-4 February 1999, Lausanne (Switzerland). This publication was realised within the framework of the T.M.C. Asser Institute's research project on international sports law and with the cooperation of the International

Olympic Committee.

It is a comprehensive follow-up publication

to Basic Documents of International Sports Organisations (1998) which contains, inter alia, the full texts of the Olympic Charter, the Statutes of the Court of Arbitration for Sport. and the Statutes and Constitutions of the international Olympic sports federations. Doping Rules of International Sports Organisations provides an invaluable source of reference for sports officials, legal practitioners and the academic world. It is an indispensable tool for any possible international unification, harmonisation or further approximation of the rules on doping in sport. The text of the new Olympic Movement Anti-Doping Code, which will enter into force on I January 2000, is included as an addendum to this publication.
