A Preliminary List of European Scholars in American Labor and Working-Class History

In November 1978, thirty-five scholars from a dozen countries met at the University of Bremen for a symposium on "American Labor and Immigration History." One of the goals of this symposium was to increase the possibilities for international cooperation. Many questions about the American working class cannot be answered without comparative research into the immigrants' cultures of origin. The "American" working class was in fact for a long period an international working class, a part of the international movements of large numbers of workers at the turn of the century. The ever-recurring hypothesis of American "exceptionalism" can also only be answered by a detailed comparison with developments in European countries. Comparative research today, given the degree of specialization, of necessity has to be a collective effort.

The Bremen meeting decided to promote a project to lay the basis for such comparative work by initiating a preservation program for immigrant labor and radical periodicals. Secondly, it authorized reports on the "state of scholarship" to be prepared for *Labor History*. Finally, to facilitate contacts between scholars, it suggested that a list of European scholars be prepared.

This listing includes names (but no titles), institutional affiliation and institutional or private address ("Priv.:"), followed by a brief indication of the respective scholar's special interest. Names are reproduced according to the spelling in the respective country unless those scholars themselves sent only English translations or translitterations.

Note: No claim is being made that the listing is complete. The compiler has been aided by numerous individual scholars, American Studies associations and cen-

ters, but many names are missing. Any scholar who wants to be included into the listing should write to the compiler (Universität Bremen, Postfach 33 04 40, D-2800 Bremen, West-Germany) indicating his or her special interest by June 1980. The supplementary listing will also include scholars from countries to which no contacts have been established until now.
