Since the loss of the American colonies in 1783, the history of Westminster and Colonial Parliaments have been something of a lost child in the British-Atlantic past. This collection of papers examines the historiography as well as the history of the relations between the legislatures of the thirteen American colonies, Quebec and the British West Indies, and Westminster in the seventeenth and eighteenth centuries. A more global view is taken of the English-speaking Atlantic world and parliamentary and legislative concerns are brought out of their parochial confinement.
