The book joins the two volumes which have been published in 1967 and 1973. It deals with contracts and torts in international conflicts law, the latter subject having been the senior author's main interest. The book was completed after the death of the senior author (1974) by the junior author, now Professor of Law at the University of Munich. As in the previous volumes the authors preserved the original concept of a comparative analysis by using the framework of American international conflicts law. As to contracts, the book discusses the dichotomy of classic conflicts rules and independent and unilaterally imposed statutes with extraterritorial reach. A clear distinction is made between the freely negotiated agreements and adhesion contracts. In torts, however, the modern crisis of conflicts law is seen against the background of accident liabilities which are distinguished from admonitory torts.
