

NOTES ON THE CONTRIBUTORS

RICHARD M. BIRD, a professor of economics at the University of Toronto, has also taught at Harvard University and served as chief of the Tax Policy Division of the Fiscal Affairs Department of the International Monetary Fund. At various times and in various capacities, he has worked on fiscal issues in many countries of Latin America and other parts of the world, and he has published widely on the subject.

JAMES MCGUIRE is Assistant Professor of Government at Wesleyan University. He has written on Argentine political parties, unions, and strikes and is preparing a book on Peronism.

SYLVIA MAXFIELD is Assistant Professor of Political Science at Yale University. She has published widely on international political economy issues and is currently working on a book about the politics of finance in newly industrialized countries.

LOUIS A. PEREZ, JR., is Graduate Research Professor in the Department of History at the University of South Florida in Tampa.

ARAXIE CHURUKIAN is Special Collections Librarian and lecturer in Middle Eastern history at the University of California, Riverside.

CLARENCE ZUVEKAS, JR., is an international economist with the U.S. Agency for International Development. He is the author of *Economic Development: An Introduction* and coauthor of *Income Distribution and Poverty in Rural Ecuador, 1950–1979*. He has also contributed essays on Central American economic development to several books.

DIANE E. DAVIS is Assistant Professor of Sociology and Historical Studies at the New School for Social Research. A specialist on Mexico, she has published articles in various journals on economic crisis, urban politics, regime change, and one-party rule. She has just completed a book manuscript on politics and economic development trajectories in twentieth-century Mexico entitled "Rapid Transit to Ruin: Urban Conflict in the Political Transformation of Mexico, 1910–1988."

JORGE SCHVARZER directs CISEA, a private research institution in Buenos Aires, having served on its research staff for the past fifteen years. An economist, he has published several books and articles on the Argentine economy and industrialization policy, including *La política económica de Martínez de Hoz, 1976–1981* (Buenos Aires: Hyspamérica, 1986) and *Promoción industrial en Argentina* (Buenos Aires: CISEA, 1987).

JUDITH ADLER HELLMAN is Professor of Political Science and Director of the Graduate Diploma in Latin American and Caribbean Studies at York University, Toronto. The author of *Mexico in Crisis* and *Journeys among Women: Feminism in Five Italian Cities*, she is currently studying responses to the debt crisis in Mexico.

SAM ADAMO is a Latin American historian specializing in modern Afro-Brazilian history. He is currently conducting research for the public schools in Albuquerque, New Mexico.

STEPHEN J. RANDALL holds the Imperial Oil–Lincoln McKay Chair in American Studies in the Faculty of Social Science at the University of Calgary. He has written *The Diplomacy of Modernization: Colombian-American Relations, 1920–1940*, *United States Foreign Oil Policy, 1919–1948*, and *Hegemony and Interdependence: Colombia and the United States, 1810–1990* (forthcoming from the University of Georgia Press).

VIRGINIA GARRARD BURNETT received her Ph.D. in history from Tulane University in 1986. She is currently on the faculty of the Institute of Latin American Studies at the University of Texas at Austin.

JEFF LESSER is Assistant Professor of Latin American History at Connecticut College. He is currently working on a book exploring the relationship of ethnicity, immigration policy, and notions of socioeconomic development in Brazil in the first half of the twentieth century.

CELSO RODRIGUEZ is Senior Specialist in the Department of Cultural Affairs of the Organization of American States in Washington, D.C. The editor of the *Inter-American Review of Bibliography/Revista Interamericana de Bibliografía*, he is also responsible for the Program for the Development of Latin American Archives. He has written *Lencinas y Cantoni: el populismo cuyano en tiempos de Yrigoyen* and is currently preparing a book on public perception of the Argentine presidency of Arturo Illia.
