Footnotes should be double-spaced and placed at the end of the manuscript. Library of Congress transliteration should be used. In general, articles should not exceed twenty-five pages, except where especially justified, e.g., by extensive documentation, tables, or charts. Manuscripts will not be returned unless specifically requested and postage is provided. The policy of the *Slavic Review* is not to consider materials that have been published or that are being considered for publication elsewhere.

Publication of articles in the *Slavic Review* is ordinarily limited to those submitted by members of AAASS. Nonmembers wishing to submit manuscripts are asked to request a membership application.

Authors who wish to have their manuscripts considered anonymously should request so explicitly and prepare manuscript copies accordingly.
