

A Story of Conflict and a Measurement of Conflicting Rights Alfred Winslow Jones Edited by Daniel Nelson


In the fall of 1938, Alfred Winslow Jones, a Columbia University graduate student, interviewed 1,705 Akron, Ohio, residents in order to gauge attitudes toward large corporations. *Life, Liberty, and Property* reports the actual comments of these interviewees on a broad range of issues. Their statements provide a compelling and often colorful commentary on life in a divided and anxious midwestern city. By 1938, the worst of the Depression was over, but jobs remained uncertain. The international turmoil that would lead to World War II was beginning to be a source of concern. Most of all, the appropriate roles for government and big business in a democratic society troubled Akron residents. Jones's interviews illuminate the whole range of public issues at a critical juncture in

American history. Life, Liberty, and Property is an invaluable source on Ohio, on the Midwest, and on American

society.
