#### Manuscripts

The China Quarterly welcomes the submission of manuscripts from scholars, including postgraduate students, on all aspects of contemporary China and from all points of view, including those which deal with Taiwan and Overseas Chinese. Articles on China prior to 1949 are also welcome, particularly, but not exclusively, when these relate directly to contemporary China or to the history of the Chinese Communist Party. Articles should be submitted in quadruplicate to the editorial office. They should normally not exceed 8,000 words in length; should be typed in double spacing, with footnotes at the end; and should conform to the styling of *The China Quarterly* (see below). An abstract of 100–150 words should also be provided for on-line promotional purposes. Submission of a manuscript is taken to imply that it has not previously been published in any form (including non-copyrighted working papers) and that it is not currently being considered elsewhere.

The China Quarterly is published by Oxford University Press on behalf of the School of Oriental and African Studies, University of London. The views expressed in articles are those of individual authors and do not necessarily represent the views of the School.

#### Style

#### Romanization

*Pinyin* is used without tone/diacritical marks, except the following which should use the Wade-Giles system: names such as Chiang Kai-shek, Sun Yat-sen, Taipei and Kuomintang; names of individuals living outside mainland China. Chinese characters should be provided on the first occurrence of each romanization, to assist in proofreading.

This work explores state building and the processes by which supporting state bureaucratic organizations aided the state building effort in Republican China between 1927 and 1940. It suggests that, in hostile environments profoundly non-congenial to state building efforts, it is the state organizations that stand the best chance of becoming well institutionalized. This work details the administrative histories and institution-building strategies of three organizations in Republican China dealing with the national civil service, taxation, and foreign affairs.

## Centre and Provinces: China 1978–93

POWER AS NON-ZERO-SUM

#### LINDA CHELAN LI

This book constructs an interactive model of power to explain the relations of the central and provincial governments in reform China. Power in a context of interdependence flows from both sides. Unlike most previous analyses, Centre and Provinces: China 1978–93 argues that provincial noncompliance is partly the product of central policy as well as provincial choice. An adequate understanding of change requires full recognition of this mutuality of power and its manifestations. Compromises are struck amidst protracted conflicts and interdependence, resulting in a more institutionalized form of relations.
