ALEXANDRE CIORANESCU: born in 1911; docteur ès lettres at the Sorbonne; professor at the University of La Laguna, Canary Islands; author of numerous works on literary history, comparative literature and the history of culture published in Rumanian, French and Spanish. Among the most recent: *Bibliographie de la littérature française* (XVI^e-XVIII^e siècles, 7 vols.); L'Avenir du passé, utopie et littérature; España en el siglo clasico francès.

BERNARD FROUSSART: born in 1935; studies at Paris V (Institut d'études projectives); chargé de cours at Université de Dijon, 1978-1982; psycho-clinician at the Centre hospitalier spécialisé de la Chartreuse de Champmol, Dijon; for the last ten years he has been researching on familial structure and its organization.

VANIA DE GILA-KOCHANOWSKI: born in Cracow in 1920; studies at Riga; doctorate in linguistics in Paris and in ethno-sociology at Toulouse-Le Mirail; numerous visits to India (attaché at the International Academy of Indian Culture and at the methodology section for setting up interdisciplinary research on Indo-Romani history of the Indian CNRS). Author of a dictionary of Romani and of numerous studies on the gypsies of Europe, their languages and their migrations.

REECE THOMAS HARRIS: born at Shreveport in 1932; studies in mathematics at the University of Illinois (Ph.D.); has taught at the universities of California (Berkeley), Maryland and New York. Visiting professor at the universities of New York and California (Santa Cruz).

MESSAY KEBEDE: born in 1945 in Ethiopia, doctorate of philosophy at the Université de Grenoble in 1976. At present he directs the department of philosophy at the University of Addis-Ababa. He is currently engaged in extensive research on development and cultural change.

TADEUSZ KOWZAN: born in Wilno in 1922; literary studies first in Poland then in France (docteur ès lettres, 1964); subsequently directeur adjoint of the
