Announcement

During the past year we have undertaken several projects which we hope will enhance *The Review's* overall appeal to readers and contributors and ensure its future in the scholarly community. Starting with our Winter 2002 issue we announce several changes in procedure and several innovations in our basic operations.

The Review's web page (<http://www.nd.edu/~rop>), which many of you already know, now contains cumulative indices from 1939 to the present for both articles and book review essays. With the simple control/F search feature a visitor to the site can search the entire archive of articles or of reviews by author, title, or key word. Our web page also provides other useful information on advertising rates, subscription prices, forthcoming articles, and instructions on submissions. A new feature on the web page which we believe improves procedures is the secure site on the subscription application forms. Though we are not prepared to accept direct transactions through the web page as yet, with the secure site a subscriber is protected when submitting credit card information.

Also with this issue the Instructions for Contributors change. The Editors believe it is more efficient and less costly if authors submit their manuscripts with a computer disk and only two hard copies instead of the four copies which were previously requested. This announcement, with complete details on specific requirements for submissions, will appear on the Instructions to Contributors page in each issue of *The Review* and on the web page submission site.

But the most far-reaching innovations we have embarked on will not affect most of you for some time to come. As of this present issue *The Review* has entered yet another phase of its ongoing process of staying abreast of technological advances in the profession. The University of Notre Dame on behalf of *The Review of Politics* has contracted with EBSCO Publishing to act as the preferred provider of aggregate access to the journal. Principally in this capacity EBSCO will oversee and police the use of *The Review* on the Internet. The business complications of Internet access to print material are too great for us to manage alone. Chiefly the agreement is aimed at libraries and other research centers which purchase journal and scholarly material through agencies which bundle various sources into one data base. This arrangement with EBSCO protects us from unlicensed use of our journal and hopefully will encourage new subscribers.

Along with securing a preferred provider of aggregate use, we have been looking into the possibility of making available to all subscribers electronic access to *The Review* through our web page. It is our intent that individual subscribers will in the near future have the ability to directly download material from our web page or at least have the ability to make use of articles and reviews through the web page. Presently we are making arrangements with the University Web Administrator so that *The Review* can make available electronic access to recent and forthcoming issues of the journal. When it is accomplished, we will announce it on our web page.

The Review is committed to maintaining excellence and to keep up with the times as well. We hope you find these changes positive and will continue to support us in our work.

INSTRUCTIONS TO CONTRIBUTORS

All manuscripts should be submitted in **DUPLICATE** with an accompanying computer disk of text to Professor Walter Nicgorski, Editor, *The Review of Politics*, Box B, Notre Dame, IN 46556. If the return of the manuscript is desired, a stamped, self-addressed envelope should be enclosed. All typewritten material should be double-spaced, including notes and quotations; photocopies of a good quality are acceptable. *The Review* follows the *Chicago Manual of Style* for standards of citation, punctuation and other editorial considerations. The normal length of manuscripts published is 8,000–11,000 words. Since manuscripts are evaluated anonymously they should not bear the author's name or institutional affiliation. Submissions should be sent with an **ABSTRACT** of 100–150 words. We assume, in accordance with APSA policies, that you have not submitted your essay to another journal. All correspondence regarding book reviews should be sent to Professor Peter R. Moody, Jr. at the above address.
