THE CONTRIBUTORS

EDWARD FEIT is Assistant Professor of Government at the University of Massachusetts, Amherst, and is this year a Fellow at the Mershon Center, The Ohio State University, where he is at work on a study of insurgency in South Africa and on a comparative study of military regimes.

GUENTHER ROTH is presently Visiting Professor at the Free University of Berlin. This spring he will publish the first complete English edition of Max Weber's *Economy and Society*, which, with Claus Wittich, he has edited and partly translated.

JAMES P. SPEER II is Associate Professor of Political Science at Temple Buell College in Denver. He has also taught comparative and international politics at the University of Colorado and at Colorado State University. Before he began his teaching career, he was a Foreign Service Officer in Mexico, Chile, India, and China.

HANS O. SCHMITT is Associate Professor of Economics at the University of Wisconsin. During the period 1965-1967 he served in Washington as an economist with the International Bank for Reconstruction and Development.

TED GURR is Assistant Professor of Politics and Associate Director of the Workshop in Comparative Politics at Princeton University. He is conducting a series of comparative studies of the sources of political instability and is the author of the Center of International Studies monograph *The Conditions of Civil Violence: First Tests of a Causal Model* (1967).

KLAUS EPSTEIN died on June 26, 1967, as a result of an automobile accident that cut short a distinguished career of scholarship and teaching. At the time of his death, Professor Epstein was Chairman of the History Department at Brown University. He had recently published, as the first volume of a major work, *The Genesis of German Conservatism* (1966). He was on a number of occasions a valued contributor to *World Politics*.

PHILIP GREEN is Assistant Professor of Government at Smith College and the author of *Deadly Logic: The Theory of Nuclear Deterrence* (1966).

GEORGE ENTEEN, Assistant Professor of History at The Pennsylvania State University, spent the fall of 1966 in Moscow and Leningrad doing research for a work to be entitled *M. N. Pokrovskii and the Society of Marxist Historians*.

C. P. KINDLEBERGER is Professor of Economics at the Massachusetts Institute of Technology, on leave as Visiting Professor of Economics, Atlanta University Center. His latest book is *Europe's Postwar Growth: The Role of the Labor Supply*, which appeared in 1967.
