THE POLITICS OF CHINESE COMMUNISM

Kiangsi under the Soviets

Ilpyong J. Kim

The political system established by the Chinese Communist Party in 1949 had its origins, in many respects, in the Chinese Soviet Republic of 1931–1934 in southern Kiangsi province. This period was important because it gave the Chinese Communists their first opportunity to govern an extensive area and to develop methods of mass mobilization. Mr. Kim explores the evolution of the Kiangsi soviet, especially its organizational concepts and development of “mass line” politics.

SMALL GROUPS AND POLITICAL RITUALS IN CHINA

Martin King Whyte

Mr. Whyte examines two political mechanisms that have helped to bring order to China since 1949: small-group political study and mutual-criticism rituals, in which much of China regularly participates. He presents case studies constructed from more than 700 hours of intensive interviews with former residents of China in order to illustrate the range of successes and failures of these rituals, and concludes that, although they have promoted order and prevented opposition, they have been less successful in achieving their avowed goal of effecting day-to-day reform in the attitudes of their participants.

CAPITAL FORMATION IN MAINLAND CHINA 1952-1965

During the past two decades the Chinese government has marshaled enormous economic resources for the purpose of capital formation, but precisely how successful these efforts have been is unclear because official statistics are incomplete. Dr. Chao attempts to provide a comprehensive measurement of fixed capital investment in China by taking into account each investment component and each capital goods item installed in China since 1949.
