## International Decade of OCEAN EXPLORATION

The National Science Foundation's Office for the International Decade of Ocean Exploration (IDOE) has established a Marine Science Affairs program to support research on the social, economic, political, and managerial implications of the IDOE scientific program. This program consists of long-term, multi-disciplinary oceanographic projects in four major programs: Environmental Quality, Environmental Forecasting, Seabed Assessment, and Living Resources.

Emphasis in the Marine Science Affairs program will be on: (1) the public policy implications of new knowledge generated by IDOE scientific programs; and (2) research likely to help improve the conduct and management of the IDOE program.
Among the kinds of public policy issues that may be addressed are the social, political, and economic implications of improved long-range weather and climate forecasts; the legal and regulatory implications of new findings in marine pollution research; the resource manage-
ment implications of a capability to predict coastal upwelling; and the foreign policy implications of improved environmental predictive capabilities. Collaboration with ongoing IDOE scientific projects is seen as particularly important for analysis of these kinds of problems.
Problems associated with the conduct and management of the IDOE and other large environmental research programs include those involved with the international IDOE program; the effectiveness of decentralized forms of scientific management; the nature of communication with in the oceanographic community; and the effectiveness of mechanisms for getting IDOE findings to potential users. Proposals for workshops and symposia to convey significant research from both the IDOE scientific and marine science affairs projects will also be considered for support under this category.
The program will begin with about $\$ 200,000$ in Fiscal Year 1977. ## HUMAN RIGHTS Documents Publication

The Tariton Law Library of the University of Texas School of Law has announced the release of its new monthly publication, the Checklist of Human Rights Documents, edited by WinShin Chiang and published in cooperation with the United States Institute of Human Rights.

The first section is a bibliographic listing of documents issued by international, national, non-governmental, and special organizations as well as commercial publications in the field of international protection of human rights. Some of the organizations included are the United Nations, the Council of Europe, the Organization of American States, the International Labour Organisation, UNESCO, the United States Congress, and the World Peace Through Law Center.
The second section lists instruments of accession and ratification received by the United Nations to conventions and protocols of human rights. The third section consists of Announcements where planned and upcoming events and activities such as conferences to be held, seminars to be conducted and courses to be offered are publicized.
The first issue of the Checklist is a cumulative one, covering the period from January through May 1976. The cost of this issue is $\$ 5.00$ per copy.

Beginning with the next issue, volume 1 , number 6, June 1976, the Checklist will be published on a monthly basis. Subscriptions are accepted on a yearly basis only, at the rate of $\$ 25.00$ per annum, from June through May.

## U.S. House Subcommittee on Emergency TRADE LEGISLATION

The House Subcommittee on International Trade and Commerce will conduct studies leading to public hearings during the first six months of 1977 on the advisability of revising or repealing section 5(b) of the Trading With the Enemy Act of 1917. This section authorizes the President to exercise extensive controls over international economic transactions in time of declared national emergency. Since the nation has been in a declared state of emergency since 1933, these authorities are in effect available for the day-to-day conduct of foreign policy. They are currently used by the administration to impose trade embargoes on North Korea, Vietnam, Cambodia, and Cuba, and for routine export controls normally exercised under the temporarily-lapsed Export Administration Act.
The Subcommittee recently published a complete legislative and administrative history of section 5(b) entitled, "Trading With the Enemy: Legislative and Executive Documents Concerning Regulation of International Transactions in Time of Declared National Emergency." This volume is available in limited quantities from the Committee on International Relations, House of Representatives, Washington, D.C. 20515, and for $\$ 2.75$ from the Government Printing Office, Washington, D.C. 20402.
The Subcommittee would like to hear from scholars and other interested people engaged in analyzing possible changes in U.S. laws to provide a better basis for both routine and emergency foreign economic and trade policy. ## Alternative CAREER Survey

To address some of the problems inherent in the projected surplus of Ph.S.'s the Higher Education Research Institute (HERI) in Los Angeles has launched a project, funded by the Ford and National Science Foundations, to identify nontraditional job markets for academics and determine entry points for new Ph.D. recipients.
Since information about the migration of Ph.D.s into and out of academic employment and within or between academic institutions and business is the weakest link in the knowledge of manpower flows, HERI will first endeavor to refine projections of job availability by collecting data on mobility of doctorate holders. The HERI study will determine the most fruitful nontraditional markets and whether they represent "enrichment" or serious "underutilization" or underemployment of Ph.D.s. It will also suggest new areas for productive employment.
HERI will survey those in nontraditional jobs to determine why doctorate holders take such employment and to evaluate job satisfaction and other career outcomes. The study will compare backgrounds, training, and attitudes of those in traditional and nontraditional careers.

To analyze the reasons behind the moves of mobile doctorate holders, the HERI study will ask such questions as: Were Ph.D.s attracted to new jobs by good offers, or were they forced from previous jobs? Are those who change jobs in the current market happier in their new jobs? How could intersectoral moves be encouraged or reduced in the future?

The study will sample 15,000 doctorate holders from 14 science (physical, biological, and social) and engineering fields who have moved out of or into nonacademic jobs in the last three years. The nontraditional employment areas into which senior personnel have moved represent potential new markets for science and engineering doctorates.
HERI will also survey Ph.D.s who have moved between academic institutions, from academic or research to administrative positions within a college, university, or research organization, or within or between business firms. The study will explore the career patterns, characteristics, and routes of access of the highly mobile Ph.D.s.
The study has three major objectives:

1. To identify nontraditional job markets outside academe which offer satisfaction and utilize science and engineering backgrounds. The study will evaluate the extent to which these nontraditional markets can absorb the expected surplus of Ph.D.s and the "push and pull" factors experienced by movers.
2. To determine potential entry points for new degree recipients by looking at careers of current doctorate holders.
3. To collect data on the occupational mobility of science and engineering Ph.D.s in nontradi-
tional fields, with particular attention to the "fine" fields, those specializations within major areas.
HERI will identify the sample population through professional science and engineering associations, the academic departments of 160 colleges and universities, and 200 major U.S. corporations listed in the Fortune 500 . It will solicit participation through advertisements in several major national publications.
Requirements for participation in the study include a Ph.D. in any of the following fields: economics, mathematics, chemistry, physics, sociology, biology, political science, anthropology, psychology, civil engineering, electrical engineering, mechanical engineering or zoology.
HERI is seeking the participation of Ph.D.s who hold a nontraditional or unusual job outside the academic or traditional research areas, or who have changed employers or job functions within the past three years. ## EAST AFRICA Seminar

For the fifth year, Syracuse University will offer a five-week seminar in East Africa during July and August, 1977. The program will focus on comparative patterns of development in
contemporary Africa. Undergraduates, graduates, and teachers are eligible to participate in the seminar which carrier six hours of graduate or undergraduate credit in social science.
Marshall H. Segall, Chairman of the Social Science department of the Maxwell School of Citizenship and Public Affairs at Syracuse University, will direct the program for the second year. Professor Segall, a cross-cultural psychologist with extensive experience in African studies, is currently doing research in East Africa on a grant from the National Science Foundation.

The seminar begins approximately July 18, 1977 in Nairobi, Kenya. For two weeks participants will attend lectures given by Kenya educators and government officials, and will visit schools, clinics and cooperatives in the Nairobi area. Three weeks will be spent in travel in Kenya and Tanzania covering sites of historical and cultural importance, over areas of wide contrast physically and ecologically, and a cross-section of socioeconomic conditions.

## BRITISH Politics Group Prize

The Executive Committee of the British Politics Group takes considerable pleasure in announcing the establishment of a dissertation prize. The Executive hopes that this prize will come to play an important role in helping to achieve the BPG objectives of stimulating interest in the
study of British politics among graduate students, thereby helping to develop a new generation of scholars in the British field, and assisting in the training of new scholars.
The BPG invites nominations for an award of $£ 100$ for the best doctoral dissertation in British politics completed during the calendar years of 1975,1976 or 1977 in a political science (government or politics) department at a university in the United States or Canada. Nominations are to be made only by a supervising professor. Each professor is limited to a single nomination.
Nominated dissertations are to be submitted to the Executive Secretary, 503 Ross Hall, lowa State University, Ames, Iowa 50011 , by February 1, 1978. The principal criterion for awarding the prize shall be the dissertation's contribution to the understanding of British politics, whether that understanding derives from exclusively British research or from a comparative study. The award will be made at the BPG's annual business meeting in September 1978.

The competition is intended to be a permanent one with the frequency of the award depending upon the number of dissertations qualifying for consideration. We look forward to the award creating a good deal of interest in research efforts of young scholars.

## NRC PH.D. SURVEY

Data collected in 1975 by the National Research Council indicates that nearly 264,000 doctoral scientists and engineers were employed in the United States in 1975 while 2,500 (one percent of the labor force) were unemployed and seeking work. Of those Ph.D.'s who were full-time or part-time employed, nearly 60 percent were working at educational institutions while about 25 percent were employed by business or industry. Approximately 45 percent of the employed doctoral scientists and engi-
neers were primarily engaged in research, design, and development or the administration of these activities while nearly 37 percent were engaged primarily in teaching. These population estimates were based on responses of a sample of over 66,000 Ph.D. recipients.
These findings as well as other data pertaining to employment status, salaries, and demographic characteristics were obtained from the 1975 Comprehensive Survey of Doctoral Scientists and Engineers conducted by the National Academy of Sciences-National Research Council, under the sponsorship of the National Science Foundation (NSF) and the National Institutes of Health. This biennial survey is one of three sources of information about the scientific and engineering population in the U.S. which the NSF integrates into its Manpower Characteristics System.
In early 1977 the third biennial survey will be conducted to gather current employment and career information on a stratified sample of over 80,000 individuals who have received a doctorate in the sciences, engineering or the humanities between 1934 and 1976. The purpose of the survey is to obtain data which will help to assess the status of the nation's Ph.D.'s and to develop policies and programs which affect this important segment of the population.
