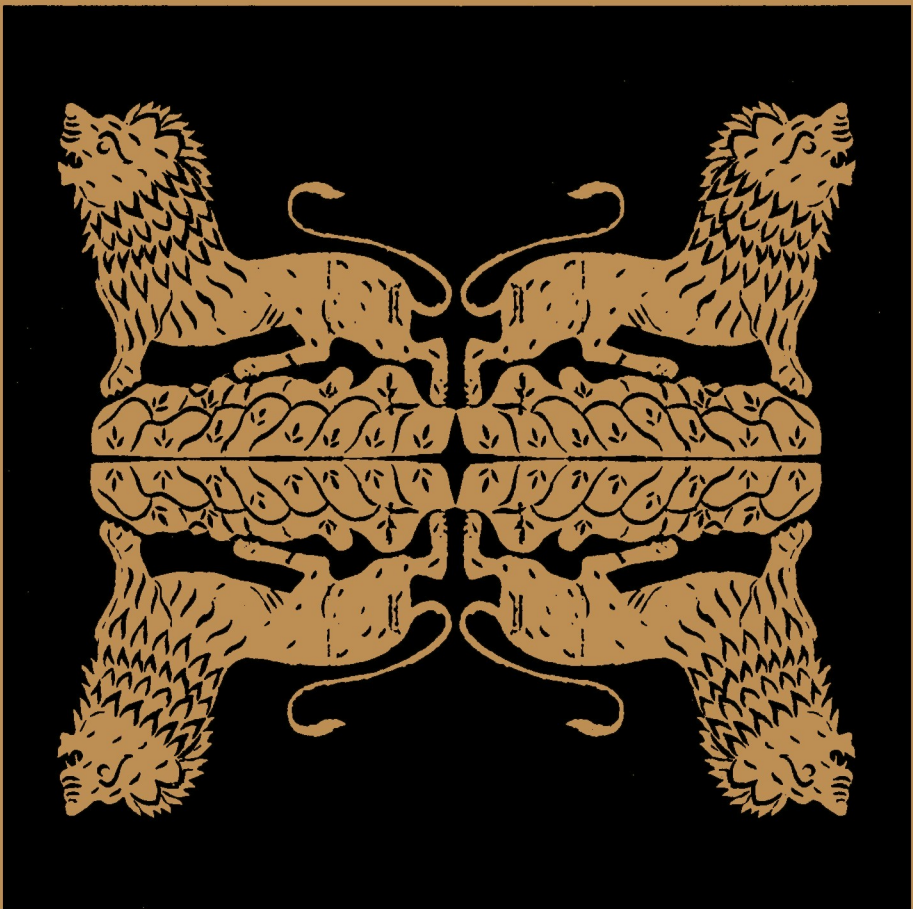

CONTRIBUTORS TO THIS ISSUE

EDWARD A. ALLEN is a doctoral candidate in history at Tulane University and an Instructor of History at Xavier University of Louisiana. His dissertation concerns the development of revolutionary opinions on the eve of the French Revolution of 1789. He has published "Guild Opinion at Rouen in 1789: An Analysis of the *cahiers de doléances*," *Human Mosaic*, (1980).

NANCY F. ANDERSON is Assistant Professor of History at the University of New Orleans. She is completing a biography of the Victorian anti-feminist Eliza Lynn Linton and is also working on a study of the psychodynamics of family life in early Victorian England.

F. J. LEVY is Professor of History at the University of Washington, Seattle. He is the author of *Tudor Historical Thought* (1967), editor of Francis Bacon's *Henry VII*, and has written articles on Tudor historiography, Sir Philip Sidney, Fulke Greville, and Henry Peacham. Currently he is working on a study of England in the 1590s.

EVELYN L. FUGH is Professor of History at George Mason University. Her publications include "Politics and Light Verse: Another Look at J.S. Mill," *Mill News Letter* (Summer 1977) and "John Stuart Mill, Harriet Taylor and Women's Rights in America, 1850-1873," *Canadian Journal of History* (December 1978). At present she is working on a study of J.S. Mill and the feminist question.

DEAN RAPP is Associate Professor of History at Wheaton College, Illinois. He has published an article on the social rise of the Whitbread family in the *Economic History Review* (1974) and is currently writing a biography of Samuel Whitbread, and studying the evangelicalism of the 2nd Earl of Dartmouth.

DAVID S. SPEAR received a Ph.D. in history this year from the University of California, Santa Barbara. His dissertation is "The Norman Episcopate under Henry I, King of England and Duke of Normandy (1106-1135)." He is co-editor of *Medieval Europe: A Short Sourcebook* (1982) and of several articles to be published this year.
