His current research focuses on indigenous development via practical anthropology.*

ANN ZULAWSKI, *Assistant Professor of History and Latin American Studies at Smith College, is currently completing a book on the development of an indigenous labor force in the Andes during the colonial period. She is interested in changing conceptions of class and ethnicity in colonial and national Latin America.*

FERNANDO LOPEZ-ALVES, *Assistant Professor of Political Science at the University of California, Santa Barbara, has published articles on Soviet–Latin American relations, unions, and urban guerrilla movements. His current research focuses on employer associations and Hispanics in the California work force.*

He has published articles on the plight of the Panamanian press and the chapter on Latin America in the second edition of Global Journalism.
