

SUMMER WORKSHOP ON ANALYSIS OF MILITARY OPERATIONS AND STRATEGY

at Cornell University, July 11 - 30, 1999

To familiarize new scholars with strategy issues and analytical techniques, foster a network of academics competent to evaluate policy choices, support policy-relevant academic research and teaching on strategy, and maintain expertise for informed judgment on military issues within the civilian community. Topics include:

- Utility and limitations of force for achieving political objectives;
- Assessing tactics, operational plans, and strategies;
- Methodological debates about military effectiveness.

Instructors combine experience in academia, the Washington policy milieu, and military profession. Directing faculty: Richard K. Betts (Columbia), Stephen P. Rosen (Harvard), and Stephen Biddle (UNC). Seven other lecturers visit, each for a couple of days. There is also a field trip to a military installation.

Participants are housed and fed at Cornell, and receive travel expenses and a \$1-2,000 stipend (depending on professional level).

Eligibility: Junior faculty or advanced graduate students who are not necessarily committed to specialize in security studies but who will be willing to offer courses in the subject.






