

CONTRIBUTORS TO THIS ISSUE

JAMES W. ALEXANDER is Professor of History at the University of Georgia. He has published articles in *The English Historical Review*, Speculum, Neuphilologische Mitteilungen, Cîteaux, The Historian, The Academic American Encyclopedia, The Dictionary of the Middle Ages, and The Journal of British Studies. The author of biographies of Herbert Losinga, Bishop of Norwich (1091-1119) and of Ranulf III, Earl of Chester (1170-1232), he is working now on a study of chivalric, cultural, and literary patronage at the court of Edward III.

WILLIAM A. GREEN is Professor of History at Holy Cross College. He is the author of *British Slave Emancipation: The Sugar Colonies and the Great Experiment*, 1830-1865 (1976), and articles in *The Economic History Review*, *Journal of African History*, and *Journal of Interdisciplinary History*, among others. His current research involves modes of historical interpretation, periodization in history, and comparative imperial studies treating India and the West Indies in the nineteenth century.

EDWIN JAGGARD is Head of the Department of Social Sciences at the Western Australian College of Advanced Education, Perth. Two articles on aspects of early and mid-nineteenth century British electoral politics are to appear in forthcoming issues of the *Australian Journal of Politics and History*, and the *Parliamentary History Yearbook*.

ROSEMARY JANN is Assistant Professor of English at Rutgers University. She has published several articles on Victorian historiography and has just completed a book manuscript on the men-of-letters historians in the Victorian period.

SCOTT L. WAUGH is a Visiting Lecturer in History at the University of California, Los Angeles. He has completed an article on local politics in the reign of Edward II for *Speculum* (1977), and at present is working on a study of royal lordship and patronage in the thirteenth and fourteenth centuries.

ROBERT ZALLER is Professor of History at the University of Miami. He is the author of *The Parliament of 1621*, *Europe in Transition*, *1660-1815*, and a critical study, *The Cliffs of Solitude*, and co-editor, with Richard L. Greaves, of the *Biographical Dictionary of British Radicals in the Seventeenth Century*. Currently he is working on a study of capital punishment.
