On January 6, 1649, the House of Commons passed an act for "the Trying and Judging of Charles Stuart, King of England." By month's end, the King's judges had found him "guilty of High Treason and of the murders, rapines, burnings, spoils, desolations, damage, and mischief to this nation" committed during the recently-concluded Civil War. He was beheaded in full public view on January 30. How and why a king—God's anointed—was executed for treason are questions that underscore profound changes in politics and thought. To provide a window into this pivotal period, accounts of the trial and execution from contemporary newspapers, pamphlets, and official records are collected and edited for modern readers. Weightman's study is the first biography in English of one of the most influential and charismatic women of the fifteenth century, the sister of the Yorkist kings Edward IV and Richard III and the wife of Charles the Bold, the last Valois duke of Burgundy. Margaret of York was the pivot of the Anglo-Burgundian alliance (which ensured the restoration of Edward IV in 1471) and was the creator of the momentous Hapsburg-Burgundian marriage of 1477, a union which, by keeping France out of the Low Countries, put a thorn in the sides of Louis XI and Henry VII.
