2. If *edited*, a submitted book should contain original essays that adhere to a central theme rather than a reprinting of previously published work.

3. The writing and analysis should be in the tradition of V. O. Key's scholarship. This includes at least one or more of the following:

- a. The method of analysis should yield information that advances our understanding of the political world by supporting, negating, or modifying existing theory or by generating new theory.
- b. The question under examination should be theoretically relevant.
- The book should demonstrate a sensitivity to and a skill in handling theoretical questions.
- d. Quantitative methods, if employed, should be both clear and replicable.
- e. Our understanding of the political world should be enhanced and ad-

vanced by the conclusions of the study.

4. A submitted book might replicate an earlier volume, might provide fresh examination of an earlier work utilizing the same and/or newer methods of analysis.

5. A submitted book might utilize newer methods of analysis to examine an historically important political event or problem.

## Maryland Announces Public Management Program

The University of Maryland's School of Public Affairs announces a new graduate

program leading to the degree of MASTER OF PUBLIC MANAGEMENT. The primary objective of the School is to provide students with an opportunity for graduate, professional education preparing them for careers in public policy in both the public and private sectors. The School also plans to have an active research program with projects selected to be of use to federal, state, and local governments.

The School has an independent full-time faculty headed by Dean Albert H. Bowker. When it is in full operation the School will offer a Master of Public Management (MPM) degree and a Doctor of Philosophy (Ph.D.) degree in Policy Studies. The first Master's students will be full-time, and will begin the program in fall semester 1982. The mid-career program will not formally begin until fall 1983.

The purpose of the Master's Program is to develop the critical and analytical skills necessary to the understanding and managing of public sector problems. The curriculum will include quantitative. economic, political, and normative methods of analysis and acquaint students with strategies and techniques for implementation and evaluation of programs and policies. Students will also be encouraged to take elective courses in related schools and departments, including the School of Business and Management, the Department of Economics and Government and Politics, and the School of Law.

#### Non-Lawyers Study Law

Yale Law School offers a Master of Studies in Law (M.S.L.) Program which enables scholars and journalists to study law at Yale for one year. These degree candidates enroll with the first-year class in the fall and take elective courses in the spring. They compete with and are graded on the same basis as regular law students.

M.S.L. degree recipients are not eligible for subsequent admission to J.D. candidacy, nor will simultaneous application to the two programs be entertained.

#### Eligibility

The total enrollment of the program is limited to ten persons per year. For the duration of a grant from the Ford Foundation, five of these places will be reserved for journalists. Preference in filling the remaining five places will be given to college teachers and scholars for whom the program was originally designed. The minimal education requirement is, however, a bachelor's degree.

#### Selection Process

Applications consist of the following:

- 1. a complete curriculum vitae
- 2. a statement of how this program will fit the candidate's intellectual needs and career goals
- 3. transcipts of all undergraduate and graduate work
- 4. three letters of recommendation from people who have worked closely with the candidate and can comment on his or her intellectual preparation for legal study

## **GRADUATE WORK IN EUROPE**

#### Department of Government, University of Essex

The University of Essex, one of Europe's major political science centers, is keen to attract more graduate students from the United States and Canada.

The University offers no fewer than nine M.A. degrees in political science. The English M.A. differs from that in many other countries in being a self-contained, one-year degree. It is meant to be a valid degree in its own right, not merely a stopping place on the road to some other degree. It is ideal for someone who would like a "graduate year abroad," perhaps before finding a permanent job or going on to a professional school. It keeps open the option of further graduate work without committing the student in any way.

The Essex M.A.s are in the following fields: Political Theory, Political Economy, Political Behaviour, Latin American Government and Politics, Soviet Government and Politics, United States Government and Politics, Western European Politics, Ideology and Discourse Analysis, and History and Philosophy of Social and Political Science.

The British Ph.D. also differs from that in many other countries in being a research-only degree. It thus permits the student to concentrate almost exclusively on a research topic that interests him or her. The resulting dissertation is expected to be of high quality, and a large proportion of Essex Ph.D.s in recent years have been published.

Among the people who teach at Essex are Anthony King, editor of *The New American Political System*; Jean Blondel, founder of the European Consortium for Political Research, author of *World Leaders* and co-author of *The Government of France*; Bo Särlvik and Ivor Crewe, co-authors of *The Conservative Victory in Retrospect*; Robert Goodin, author of *The Politics of Rational Man* and *Manipulatory Politics*; Mary McAuley, author of *Politics and the Soviet Union*; Bob Jessop, author of *Theories of the Capitalist State*; and Graham Wilson, author of *Unions and Politics: The American Experience* and *Interest Groups in the United States*.

Essex is the home of the European Consortium for Political Research, the Essex Summer School in Social Science Data Analysis, the SSRC Survey Archive, the British Election Study, and the *British Journal of Political Science*.

Foreign scholars who have visited Essex for a year or more include Fred I. Greenstein, Hugh Heclo, Robert Alford, Samuel C. Patterson, Jack Dennis, Charles Anderson, Richard Merelman, and Richard Simeon.
