Contributors

Jonathan Ablard is Associate Professor of History at Ithaca College. He is the author of *Madness in Buenos Aires: Patients, Psychiatrists, and the Argentine State, 1880–1983.*

Jesse Cromwell is Assistant Professor of Colonial Latin American History at the University of Mississippi. His publications include the articles "More than Slaves and Sugar: Recent Historiography of the Trans-imperial Caribbean and Its Sinew Populations" (2014) and "Life on the Margins: (Ex) Pirates and Spanish Subjects on the Campeche Logwood Frontier, 1600–1716" (2009). His forthcoming book project, "Choppy Waters: Smuggling in Development of Commerce and Community in Eighteenth-Century Venezuela," is under contract with the Omohundro Institute of Early American History and Culture.

Nicole Mottier is Assistant Professor at Stetson University. Her current research projects include the history of peasant loans in Mexico and an 80-year history of organized crime in Ciudad Juárez.

Mary Kay Vaughan is emerita Professor of History at the University of Maryland College Park. She has served as president of the Conference on Latin American History (CLAH), co-editor of the Hispanic American Historical Review, cofounder of the Red de Historiadores de la Mujer y el Género en México, and member of the Binational Executive Committee of Congress of Mexican, United States, and Canadian Historians. She is the author of several monographs, including Cultural Politics in Revolution: Teachers, Campesinos and Schools in Mexico, 1930-1940, which was awarded the Herbert Eugene Bolton Prize from CLAH and the Bryce Wood Award of the Latin American Studies Association. She is also author of Portrait of a Young Painter: Pepe Zúñiga and Mexico City's Rebel Generation and co-editor of four collections: Women of the Mexican Countryside, 1850–1990, Escuela y sociedad en el periodo cardenista, Sex in Revolution: Gender, Politics and Power in Modern Mexico, and The Eagle and the Virgin: National Identity, Memory and Utopia in Mexico, 1930–1940. Her research has received support from the Social Science Research Council, the Fulbright Scholar program, the National Endowment for the Humanities, and the John Simon Guggenheim Foundation.
