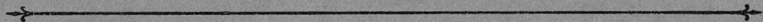

The supplementary issues in March include a Bibliography of scholarly books and articles in the field of the modern languages and literatures for the preceding calendar year, a compilation of Research in Progress, the Proceedings of the Annual Meeting of the Association, and the List of Members. The supplementary issue in June or December is an announcement, in pamphlet form, of the expected Proceedings.
