The Royal Society and its Fellows, 1660-1700: The Morphology of an Early Scientific Institution - 2nd edition, 1994, £10.00(US\$19.00) 291pp. Having proceeded from its original status as a lengthy paper in Notes and Records of the Royal Society (1976) through various impressions as a BSHS Monograph it is now easily regarded as a comprehensive and perhaps the definitive version.

No 8: Michael Shortland (ed):

Science and Nature - £10.00(US\$19.00) 291pp. Illustrated.

A collection of original essays tackling varied historical aspects of this challenging new field. Authors include Bowler, Boon, Cittadino, Kingsland, Kwa and Sheail.

No 9: Maurice Crosland:

In the Shadow of Lavoisier: the 'Annals de Chemie' and the Establishment of a New Science - £9.00(US\$17.00) 354pp. Illustrated.

The author has discovered manuscript records of the editorial board of *Annales* which was an instrument for the propagation of Lavoisier's new system of chemistry and became a European journal of international significance. This is the first detailed study of the journal and places it in both the context of the internal history of science and in the wider social and economic context of publication history.

No 10: Joe Lester & Peter Bowler:

E Ray Lankester and the Making of Modern British Biology - £9.00(US\$17.00) 219pp. Illustrated.

The biographers have had the benefit of access to a major collection of Lankester's papers hitherto not available and still in private hands. Joe Lester produced the original work and Peter Bowler has made some additions and critically edited the text from the viewpoint of a historian of science. This is a highly readable book giving as a bonus many tastes of the social flavours of the time.
