CONTRIBUTORS

Geoffrey Jones is professor of business history in the economics department of the University of Reading, U.K. He received his M.A. and Ph.D. from Cambridge University, and taught economic history at the London School of Economics from 1979 to 1988 before moving to Reading. He is the author of many articles and of several books, including *The State and the Emergence of the British Oil Industry* (1981), *Banking and Empire in Iran* (1986), *Banking and Oil* (1987), *British Multinational Banking 1830-1990* (1993), and *The Evolution of International Business* (1996). His article (co-authored with Frances Bostock) "U.S. Multinationals in British Manufacturing before 1962" received the Newcomen Award for the best article published in the *Business History Review* for 1996. At present he is completing a book on the evolution of U.K.-based trading companies from the nineteenth century to the present and researching a commissioned history of Unilever 1965-1990.

Dean Kotlowski teaches history at Indiana University and Butler University. He holds a B.A. in history and political science from Canisius College and an M.A. in U.S. history from Indiana University, Bloomington. He will receive his Ph.D. from Indiana University this autumn. His articles have appeared in *Journal of Policy History*, *The Historian*, and *Presidential Studies Quarterly*. Presently, he is completing a study of the Nixon administration and civil rights policy.

James D. Rose is an instructor of history at the University of California, Davis. He has published in the journal *Labor History* and is the author of the forthcoming book, *Steel Unionism at Duquesne: A Shop Floor History* (Urbana: University of Illinois Press). His next project is a study of the corporate reorganization of US Steel during the 1920s and 1930s.

Judith Wale is lecturer in accounting, University of Warwick Business School; visiting research fellow at the Centre for International Business History, University of Reading; and visiting research associate in the Business History Unit at the London School of Economics and Political Science. Her publications include studies of bank-industry relations in Britain, accounting history, and the British coal industry. Currently she is working on management strategies and performance in the coal industry during the interwar years.
