This is a study of quantifiable changes in organized religion during successive periods of industrialization, secularization, political change, and war. The authors analyse the cycle of church growth, and argue that church policy has on the whole less effect on membership changes than external influences. £16

Westminster Abbey and its Estates in the Middle Ages

Barbara Harvey

In 1535, on the eve of the Dissolution, the monks of Westminster were the lords of vast estates and the second wealthiest religious house in the kingdom. This book traces the accumulation of these properties from modest beginnings over a period of six centuries. It examines how the monks' role as landlords changed and the consequences of these changes for their tenants, and shows how slowly the monks responded to economic trends. £15

The Coherence of Theism

R. G. Swinburne

The author investigates what it means, and whether it is coherent, to say that there is a God. He concludes that many, though not all, of the claims about God which religious believers make are coherent, and that some important claims are coherent only if the words by which they are expressed are being used in stretched or analogical senses. £9

From the introduction:

"Regional cults are found in many parts of the world. They are cults of the middle range – more far-reaching than any parochial cult of the little community, yet less inclusive in belief and membership than a world religion in its most universal form. Their central places are shrines in towns and villages, by cross-roads or even in the wild, apart from human habitation, where great populations from various communities or their representatives come to supplicate, sacrifice or simply make pilgrimages."

This book (which is derived from the 1976 ASA Conference) is the first attempt by social anthropologists to create a theoretical framework for the comparative analysis of these cults. It gives the study of religious organizations a new perspective on major historical transformation from the pre-colonial past to the neo-colonial present, in North and South-central Africa, South America and the Middle East. It advances a basic debate about opposed theories of religion and society inspired by Robertson Smith, Durkheim and Marx. The focus is on the problems of change in transcultural symbolism and relationships which cross political, economic or ethnic boundaries.

NOTES FOR CONTRIBUTORS

1. Contributions and books for review should be sent to the Editor, Professor H. D. Lewis, King's College, Strand, London, WC2R 2LS. Books published in America should be sent to Professor J. E. Smith, Department of Philosophy, Yale University, New Haven.
2. Articles submitted to the journal should in general be between 5,000 and 10,000 words long, though articles outside these limits will be acceptable if there is some good reason for their exceptional length or brevity. Articles in two or more parts may occasionally be accepted provided each part is independently intelligible. They should normally be in English.
3. Submission of an article is taken to imply that it has not previously been published, or is not being considered for publication elsewhere.
4. Contributions should be clearly typed in double spacing, preferably on A4 paper, with a wide left-hand margin. The typescript should be prepared to accord as closely as possible with the typographical conventions of the journal.
5. Footnotes should be used sparingly: in general, to give sources of direct quotations, references to main authorities on disputable questions, and evidence relied on for a new or unusual conclusion. They should be numbered in one sequence throughout the article, and should preferably be typed in double spacing at the end of the article.
6. Contributors should keep one copy of the typescript for correcting proofs.
7. First proofs may be read and corrected by contributors provided that they can give the Editor an address through which they can be reached without delay and can guarantee to return the corrected proofs to the Editor, by airmail where necessary, within ten days of receiving them.
8. Correction should be kept to an absolute minimum. It should be confined to errors of the typist or printer unless the Editor authorises otherwise.
9. All contributors of articles receive 50 free offprints. Reviewers will receive five or more offprints of their reviews.
10. If rejected manuscripts are to be returned, stamps or international coupons should be sent to cover postage.
11. Contributors of accepted articles will be asked to assign their copyrights, on certain conditions, to Cambridge University Press, to help protect their material, particularly in the USA.
