Nadav Safran's book is a masterguide of insight into and analysis of the often elusive nature of the behaviour of Saudi Arabia's rulers. Safran shows that security has been the predominant concern of Saudi Arabia since its creation – on a per capita basis its defence budget is by far the highest in the world. Safran traces the roots of Saudi preoccupation with security and its expression in defence and foreign policy through half a century and four reigns. The book can thus provide a unique perspective on the Kingdom's reaction to the explosive Arab-Israeli conflict; the shifting inter-Arab alignments and rivalries; the changing balance, revolution and war in the Gulf arena; and the bewildering politics and troubles of the Yemens.

On the death of General Franco in November 1975 there was considerable uncertainty about Spain's political future. After more than 35 years of government by dictatorship, would Spain become a democracy? If so, which parties would come to dominate the new political arena? The authors examine the interplay between the party-building and electoral strategies adopted by the new elites and the political orientations and behaviour of the mass public.

Why did the German summer offensive of 1942 decline swiftly from stunning success through stalemate to disaster? Geoffrey Jukes analyses the successive phases of Hitler's decisions in the Russian campaign that ended with the great defeat at Stalingrad. He shows how Hitler seriously underestimated the Russians, listened only to generals who shared his mistaken views, dismissed those who argued or failed to achieve the wildly overambitious targets, and withdrew under stress when urgent decisions were needed. He also describes the inability of generals to unite against Hitler or to find ways to disregard or subvert impossible orders, and their fatal neglect of potential Soviet counteraction.

Notes for Contributors

- 1 All contributions should be sent to: The Editor, *British Journal of Political Science*, University of Essex, Wivenhoe Park, Colchester, Essex CO4 3SQ. They should not be sent to the Cambridge University Press.
- 2 Articles submitted to the Journal should in general be between 5,000 and 12,000 words (or equivalent in tables and figures) in length. An abstract not exceeding 120 words is required.
- 3 Notes and Comments are welcome. A Note should contain a body of original information, a new method for doing something or a new idea (speculation, argument, proof, etc.) presented in a brief and unadorned form without inessential commentary. Comments containing criticisms of articles published in the Journal and additional thoughts on them will be considered for early publication, especially if they are short – say, under 1,000 words.
- 4 Most issues of the Journal contain a Review Article – either a detailed discussion of a single book or a review of the state of some area of the discipline. Review Articles submitted without prior consultation will be considered for publication, but in their own interest contributors would be well advised not to prepare a Review Article specially for the Journal without first getting in touch with the Review Articles Editor.
- 5 Contributors should note the Journal's editorial policy, which is as stated inside the front cover.
- 6 Authors of articles and Review Articles receive twenty-five free offprints. Additional copies may be bought if they are ordered at proof stage.
- 7 Submission of an article is taken to imply that it has not been previously published and is not being considered for publication elsewhere. In the interest of authors, copyright is normally assigned to the Cambridge University Press.
- 8 *Contributions intended for publication should be submitted IN TRIPLICATE.* Contributions must be typed and may be reproduced in any clearly legible form. The preferred size of paper is A4 (8½ × 11½ in), but quarto (8 × 10 in) or the US standard size (8½ × 11 in) will also be accepted. Because of postage costs, manuscripts not accepted for publication are not normally returned to the author unless their return is specifically requested.
- 9 The entire material of any article, including footnotes, quotations, appendices, etc., should be double spaced, with left-hand margins of at least 1½ in. The preferred treatment of footnotes is that they should be numbered consecutively in the text and typed all together at the end, beginning on a fresh page.
- 10 Anyone who is preparing a manuscript for submission to the Journal is urged to follow the Journal's style sheet, which covers a number of detailed points concerning footnotes, punctuation, spelling, etc. Copies of the style sheet can be obtained from the Editor. Footnote references should always contain, in the case of books, the name of the author as it appears on the title page, the full title including any subtitle, the place of publication, the name of the publisher and the date of publication, and, in the case of articles, the name of the author, the full title, the name of the journal, the volume number, the year and the page reference (number of first and last page).
- 11 First proofs may be read and corrected by contributors provided that they can give the Editor an address through which they can be reached without delay and can guarantee to return the corrected proofs to the Editor, by air mail where appropriate, within ten days of receiving them. The master proof will always be sent directly to the Editor by the printer; contributors will receive duplicates.
