# JOHAN GALTUNG A Bibliography of his Scholarly and Popular Writings 1951—80

Johan Galtung is Norway's most cited social scientist and one of the founding fathers of peace research. He has also contributed materially to a number of other disciplines and cross-disciplinary fields such as methodology, criminology, media research, international relations, and macro-history.

While published on the occasion of his 50th birthday, this book is not a conventional **Festschrift** but rather a tool to help establish bibliographic control of Galtungism up to 1980. All the 676 publications listed in the bibliographic section have been coded with descriptors, and there are title, name, and descriptor indices.




