Kluwer Law International is proud to announce the publication of the Third Edition of Shabtai Rosenne's monumental and definitive work on *The Law and Practice of the International Court*. The First Edition was published as long ago as 1957, and was followed not only by the Second Edition, in 1965, but also by another definitive writing on the Court by Rosenne, which have established him as the undisputed expert on the Court's law and practice. The 50th anniversary of the United Nations and of the International Court of Justice provided the author with the opportunity and the incentive to re-examine what he had written about the Court. He had a wide exchange of correspondence and many conversations with Members of the Court and its Registrars, as well as with other friends who know the Court and its practices well. This led him to undertake a major reconstruction of the work, which is now divided into three substantive volumes together with an index volume.

Volume I deals with the Court as one of the principal organs, and the principal judicial organ, of the United Nations. Diplomats and legal advisers who have to deal with matters relating to the Court on a political level, in different organs of the United Nations and in other offices, will find here a full discussion of the diplomatic, political and administrative aspects of the Court's affairs.

Volume II deals exclusively with jurisdiction and the treatment of jurisdictional matters by the Court. These aspects occupy a prominent place in the Court's affairs. New forms of testing the jurisdiction of the Court have appeared and introduced serious complications into the practices, techniques and tactics of the judicial settlement of international disputes through the International Court. This volume also includes the Court's advisory jurisdiction: the advisory work has related to very difficult legal issues in matters of major political import.

Volume III is devoted exclusively to the Court's procedure. This is now a completely autonomous branch of international law, and has severed its ties with internal litigation and with classical international arbitration as embodied in the Hague Conventions of 1899 and 1907. A major change of presentation here is the chapter on the Bench. The Court has made a very sharp distinction between the Court itself, that is the judges elected in accordance with the Statute, and the Bench, that college of magistrates who hear and decide a given case.

Volume IV contains the English text of the Charter of the United Nations, the Statute of the Court and the 1978 Rules of Court, together with a full set of indexes.

The Third Edition of *The Law and Practice of the International Court* is an essential component of all International Law Libraries and an indispensable work for all those practising in the field of International Law.

War Crimes Against Women *Prosecution in International War Crimes Tribunals*

This book examines laws and customs of war prohibiting rape crimes dating back thousand of years, even though gender specific crimes, particularly sex crimes, have been prevalent in wartime for centuries. It surveys the historical treatment of women in wartime and argues that all the various forms of gender specific crimes must be prosecuted and punished. It reviews the Nuremberg and Tokyo War Crimes Tribunals from a gendered perspective, and discusses how crimes against women could have been prosecuted in these tribunals and suggests explanations as to why they were neglected. It addresses the status of women in domestic and international law during the past one hundred years, including the years preceding World War II and in the aftermath of this war, and in the years immediately preceding the Yugoslav conflict. The evolution of the status and participation of women in international human rights and international humanitarian law is analysed, including the impact domestic law and practice has had on conflict, and presents arguments as to how various gender specific crimes (including rape, forced prostitution, forced impregnation, forced maternity, forced sterilization, genocidal rape, and sexual mutilation) can be, and why they must be prosecuted under Articles 2-5 of the Yugoslav Statute.

William S. Hein & Co., Inc. is pleased to announce... *Locating United States Government Information: A Guide to Sources, Second Edition*. This work will be published in two volumes -- a basic text and an Internet supplement. The author is Edward Herman; Associate Librarian, Business and Government Documents Center, Lockwood Library, State University of New York at Buffalo.

The purpose of this book is to provide a practical "how to" guide for locating United States government publications. Its workbook format incorporates illustrations from appropriate indexes and abstracts, plus questions and answers. Emphasis is upon locating and using government information, rather than policy issues.

Many changes in government information occurred since the first edition appeared in 1983. The proliferation of electronic information on floppy disks, CD-ROMs, and the Internet is the most prominent difference. Excluding the Dialog and BRS online systems, researchers used few electronic sources in the early 1980s. The author stresses integration of traditional library resources with electronic ones, providing a balanced view of government information in the multiple formats.

The book deals with resources found in most depository libraries, such as indexes, abstracts, legislative and regulatory materials, and technical reports. It also

covers data outside the usual purview of libraries including the Freedom of Information Act, the Privacy Act, the acquisition of personal copies of government documents through the GPO sales program, a directory of information for contacting government employees who are experts in their respective fields.

The book includes sample searches and illustrations from selected significant Internet resources. These include GPO ACCESS, LOCIS, THOMAS, and FEDWORLD. Novice Internet users should replicate these to get a better handle on that medium.

Because the electronic media are constantly changing, limited descriptions of Internet sources appear in the main text. Most information about the Internet appears in an *Internet Supplement* to the book. Its arrangement follows that of the chapters. The author expects to prepare updates to the *Internet Supplement* regularly.

Prospective users include people who must locate government information on a continuing or occasional basis for either educational or professional purposes. These include practicing librarians and library school students; college and university students and faculty; attorneys, business persons, market researchers, journalists, and other professionals; and citizens who want to keep better tabs on their government.

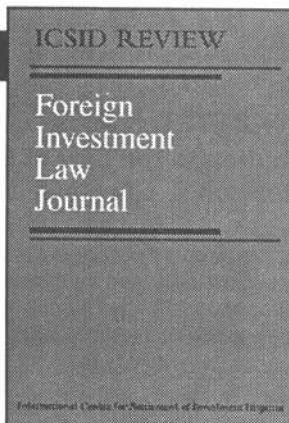

This is the only English language textbook devoted to the inter-American system for the protection of human rights. The fourth edition is the first substantial revision of the book since its original publication in 1982. It contains cases and materials concerning the inter-American legal norms, institutions and procedures concerned with human rights. Special attention is given to petition procedures and the jurisprudence of the Inter-American Court of Human Rights. Each section contains a bibliography and all pertinent documents are reproduced in the Appendix. A basic text for courses on human rights law or on the inter-American system, the book is also appropriate as a supplementary text in courses on international law, international relations and political science.

I. THE INTERNATIONAL PROTECTION OF HUMAN RIGHTS

The first chapter introduces the history and theory of human rights protection, globally and in the Americas. It also presents an overview of United Nations and regional systems concerned with human rights.

II. THE STRUCTURE OF THE SYSTEM

In this part, the institutions and legal norms of the inter-American system and how they interrelate are studied. Readings on the Inter-American Commission on Human Rights and the Inter-American Court of Human Rights are followed by cases and materials on the normative instruments of the system.

III. PROTECTING HUMAN RIGHTS IN AN INDIVIDUAL CASE

This key chapter takes students through a case from filing at the Inter-American Commission to judgment of the Inter-American Court, showing how the system protects the rights of an individual or a group through its petition process. Cases and materials present the relevant jurisdiction, admissibility requirements, procedures, evidence, and remedies for human rights violations, with discussions and questions on the functions and powers of the Commission and Court and how to improve the system.

IV. THE ADVISORY JURISDICTION OF THE COURT

The scope and impact of this important function of the Court is studied through Court opinions, from the first opinion delivered in 1982, to a recent decision declining to accept a matter submitted for consideration. The relation-

ship between the Court's advisory jurisdiction and contentious cases is emphasized here.

V. COUNTRY REPORTS AND OTHER FUNCTIONS OF THE COMMISSION

This chapter shows how the system responds to widespread violations of human rights in a particular country. Excerpts from reports of the Inter-American Commission and other sources illustrate the scope of Commission powers and consequences of a country report. In addition, the role of the Commission in studying human rights problems and drafting new instruments is illustrated through presentation of the Commission's work on the status of women and on the rights of indigenous peoples.

VI. RIGHTS AND DUTIES

In this three-part chapter, students are introduced to the scope of various rights contained in the Charter, Declaration and Convention. Cases from the U.S., Central and South America are used to analyse the meaning of the right to personal liberty and judicial guarantees, the right to religious freedom and worship, the right to freedom of expression and the guarantees of economic, social and cultural rights. The focus of part two is on the legal obligations imposed on states in the region. The problems of reservations to human rights treaties and derogations are included. The final section presents three specific current problems in the region: democracy and human rights, amnesty laws and pardons, and the death penalty.
