His extravagant self-indulgence was common knowledge, and his reputation was never high. Many letters which would have put the dubious connections of his early years in a somewhat lurid light were destroyed by loyal servants. However, the collection retains much correspondence of a private and family nature not likely to better his reputation. Nothing of substantial historical importance has been omitted. Included are letters to Mrs. Fitzherbert, whose marriage to George IV was declared illegal and therefore no impediment to his kingship.

Free Trade in Books

A Study of the London Book Trade since 1800
