Proposals for entire panels (usually two to three papers and two discussants) and proposals for individual papers will be accepted. Proposals for panels should include a title; a one-page description of the panel which discusses the rationale for the panel as constituted and the importance of the topic; a one-page précis for each paper to be included on the panel; a short vita (including address and phone number) for each person involved in the panel (chair; organizer, if different from the chair; paper presenters; and discussants). Panels may be in the form of roundtable discussions. Proposals for roundtables should include a discussion of the topic and a description of the expected contribution from each member of the roundtable. Submit a brief vita for each member. Organizers of panels and roundtables should keep in mind the commitment of the Social Science History Association to interdisciplinary and multidisciplinary interchange. Panels which include members from various disciplines will be viewed most favorably by the committee. Proposals for individual papers should include a one-page précis and a brief vita. Program Committee members will organize individual papers into panels. Proposals must be received no later than February 22, 1982. Notifications of the final composition of the program will be sent by May 15. The deadline for submission of completed papers is October 1.

 The exhibit prepared by the American Institute of Physics Center for History of Physics to commemorate Albert Einstein is now offered at a reduced price. The exhibit consists of eighteen large posters. The growth of Einstein's

scientific work is a main feature, but the exhibit devotes space to explaining his extensive public and political work, his role in world culture, and his philosophy.
