## International Political Science Association News

The lifeblood of IPSA is sustained during the three years between its world congresses by its roundtables, conferences organized by its research committees, and, since the beginning of 1980, its quarterly journal.

**IPSA Roundtables.** Two recent IPSA roundtables have focused on aspects of the international political system. The first, organized by the National Association of Political Sciences of the German Democratic Republic, took place in late August, 1980, in the town associated with two of the most brilliant eras of German history, Weimar. The topic was *De-tente: Reasons—Demands—Obstacles*. Among the papergivers were Klaus von Beyme and Ulrich Albrecht (West Germany), Daniel Frei (Switzerland), Kinhide Mushakoji (Japan), Georgii Shakhnazarov (Soviet Union), and Raimo Vayrynen (Finland) as well as several experts from the GDR. The original papers are available in microfiche from the IPSA Secretariat (c/o University of Ottawa, Ottawa K1N 6N5, Canada); a paperback edition was circulated by the National Association of Political Sciences of the GDR (Akademie der Wissenschaften der DDR, 108 Berlin, Otto-Nuschke-Strasse 10/11, German Democratic Republic).

In early January, 1981, Daniel Frei and the Research Institute for Political Science at the University of Zurich organized a roundtable on *International Crises and Crisis Management*. Besides papers by such scholars as Hayward R. Alker, Jr. (M.I.T.), Ali E. Hillal Dessouki (Egypt and Princeton), Jean Laponce and John Meisel (Canada), and Jerzy Wiatr (Poland), the conference enjoyed several contributions by members of national diplomatic corps stationed in Switzerland (such as the Rumanian ambassador and political scientist, Mircea Malitza). Of particular interest for its computer simulation based on quantitative data was the paper by V. B. Lukov and V. M. Sergeev (Soviet Union) on "Patterns of Political Thinking and Perception of International Crises." All papers are available in microfiche from the IPSA Secretariat; selected papers will probably appear later in the IPSA series, "Studies in International Political Science."

IPSA roundtables scheduled for the near future are: *Social Mobility and Political Attitudes* (August 10-13, 1981, University of Connecticut, Storrs), organized by Fred Turner; *Democracy in the Modern World: Theoretical Prospects and Contemporary Realities* (January 19-23, 1982, Mexico City), organized by Atilio Boron and Pablo Gonzales Casanova; *New International Economic Order and Political Development in Asia and the Pacific* (March 28-April 1, 1982, Tokyo), organized by Kinhide Mushakoji; and *Problems of Political and Cultural Identity* (May 1982, Senegal). Information on all these roundtables is available from the IPSA Secretariat in Ottawa.

**IPSA Research Committee Conferences.** Contained within the Association are some 21 research committees which

focus their attention on specific issues. These, together with their coordinators' addresses, were listed in the Summer 1980 issue of *PS*. One of their primary tasks is to improve international communication in their sphere of interest by convening conferences. Recent meetings and those currently being organized include:

- RC on political education: working group on "Aspects of Political Communication (especially TV and Film)," (Winter 1981, The Netherlands).
