Here six experts with varied experiences in Southeast Asia examine the ultimately inexplicable evils perpetrated by the Khmer Rouge. Accompanying their articles is a photo essay that provides shocking visual evidence of the tragedy of Cambodia's autogenocide.

Lynn White shows that the tumult of the Cultural Revolution after 1966 resulted mainly from reactions by masses of individuals and small groups to three specific policies of administrative manipulation: labeling groups, designating bosses, and legitimating violence in political campaigns. These habits of local organization were common after 1949 and gave the state success in short-term revolutionary aims, despite scarce resources and staff—but they also drove millions to attack each other later.

A fresh analysis emerges of the remarkable Marxist intellectual Fang Zhimin, who used his deeply entrenched rural connections to organize the movement through a creative synthesis of traditional folk concepts with modern Marxist thought.

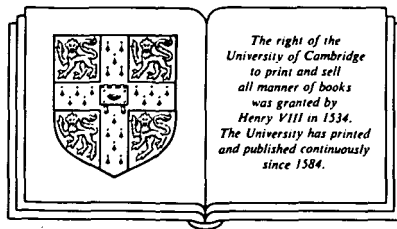

All articles (text, notes and references) must be clearly typed in double spacing throughout on one side only of the paper—preferably A4. Two copies should be submitted. Spelling, dates, references and footnote numbers should be checked for accuracy. The use of diacritical marks, italics and capital letters should be kept to a minimum. References repeated in the footnotes should be by author and short title; or the Harvard system of citation may be used.

The title of the article and the author's name and affiliation should be typed on a separate page at the beginning of the article.

Tables should be clearly laid out and numbered consecutively. Vertical lines between columns should be omitted. All figures and totals should be checked for accuracy.

Maps and figures should be clearly legible in every detail. The spelling of place names should be consistent with that used in the text.

Every table, map and figure should have a title and at least one reference in the text to indicate its location.
