CONTRIBUTORS TO THIS ISSUE

John W. Boyle is Associate Professor of History at Mount Allison University, Sackville, New Brunswick, Canada. He has edited *Leaders and Workers* (Cork, 1965) and contributed chapters to a number of volumes on Irish and labor history, as well as to Irish, French, Canadian and American journals. He is at present writing a history of the Irish Labor movement.

Bentley B. Gilbert is Professor of History at the University of Illinois at Chicago Circle. He has written a number of articles and has published four books on twentieth-century British history, the two most important being: *The Evolution of National Insurance in Great Britain* and *British Social Policy*, 1914-1939. He is currently engaged in the third volume of the series of which these two are a part.

Robert V. Kubicek is Associate Professor of History at the University of British Columbia, Vancouver, Canada, and has published *The Administration of Imperialism: Joseph Chamberlain at the Colonial Office* (Durham, 1969). He is now working on a study of the "Capitalization of the Rand Gold Mining Industry, 1886-1914," of which the above-mentioned article forms a part.

Peter Marsh is Associate Professor of History at Syracuse University, and the author of *The Victorian Church in Decline* (London and Pittsburgh, 1969), as well as of several articles on organized religion in nineteenth-century England. He is currently at work on a book on Lord Salisbury and the Conservative party from 1881 to 1902.

Richard A. Rempel is Associate Professor of History at the University of South Carolina. His book on the Tariff Reform controversy in Britain, 1903 to 1914—Unionists Divided—will appear this year.

Richard A. Soloway, Professor of History at the University of North Carolina at Chapel Hill is the author of *Prelates and People, Ecclesiastical Social Thought in England*, 1783-1852, and several articles in the area of religious and intellectual history. He is currently working on a study of the eugenics and neo-Malthusian aspects of the population question in England, 1877-1918.

Stephen J. Stearns is Associate Professor of History at Richmond College of the City University of New York.

Richard E. Willis is Assistant Professor at Tufts University, having taught previously at the University of California at Berkeley. He has published articles on parliamentary history and on Burke's political theory in both England and the United States, and is currently working on a book on the recovery of the Foxite opposition between 1794 and 1807.
