Notes on Contributors

Franz X. Eder is Professor at the Department of Economic and Social History, University of Vienna. He has carried out research on quantitative methods and discourse analysis, on the history of labour organisation, and the history of family, consumption and sexuality. Current research projects are on the history of sexuality and consumption in the nineteenth and twentieth centuries; he is finishing an introduction to the history of sexuality in Europe from ancient times to the present. He is co-editor of the Österreichische Zeitschrift für Geschichtswissenschaften and Studien zur Sozial- und Wirtschaftsgeschichte and editor of the Bibliography of the History of Western Sexuality (3rd edn, http://www.univie.ac.at/sexbibl/). His most recent publication on the history of sexuality is Kultur der Begierde: Eine Geschichte der Sexualität (rev. 2nd edn, C.H. Beck, 2009).

Jan de Graaf is a PhD student at the University of Portsmouth's Centre for European and International Studies Research. He completed his Research Master's at Utrecht University with a thesis on the international socialist movement and the decline and fall of the socialist and social democratic parties in Eastern Europe, 1944–8. The results of that thesis were reworked into two academic publications. His current project, 'Across the Iron Curtain: European Social Democracy between World War and Cold War, 1943–1948', is a comparative history of the post-war European socialist and social democratic parties, focusing on the Czechoslovakian Social Democratic Party and the Polish Socialist Party in Eastern Europe, and the French Socialist Party and the Italian Socialist Party in Western Europe.

Armin Grünbacher is Lecturer in Modern History at the University of Birmingham. His recent publications include *The Making of German Democracy: Politics and Society in West Germany During the Adenauer Period, 1945–65* (Manchester University Press, 2010, Documents in Modern History) and 'The Americanisation That Never Was: The First Decade of the *Baden-Badener Unternehmergespräche*, 1954–64 and Top Management Training in 1950s Germany', *Business History*, 54, 2. He is currently working on a monograph about the mentality of post-war German industrialists during the Adenauer years (Bloomsbury Academic, 2016), working title: *West German Industrialists and the Making of the Economic Miracle: A History of Recovery and Mentality*; and an article on the Bad Harzburg management training model during the 1950s

and 60s, working title "Palladium of Militarist Restoration or Embourgeoisement of the Workers"?: The *Bad Harzburger Akademie für Führungskräfte der Wirtschaft* in the 1950s and 60s'.

Victoria Harris is a Fellow at the University of Birmingham. Her research interests include the histories of sexuality, crime and deviance in modern Germany and wider Europe. She is the author of *Selling Sex in the Reich: Prostitutes in German Society, 1914–1945* (Oxford University Press, 2010) and 'Sex on the Margins: New Directions in the Historiography of Sexuality and Gender', *The Historical Journal*, 53, 4 (2010), and is also the English-language editor of *Letters to Hitler* (Polity, 2012). She is currently writing a book on the social history of intoxication in modern Germany and is engaged in an interdisciplinary collaborative project entitled 'Intoxication of the Senses'.

Dan Healey is Professor of Modern History in the Department of History, University of Reading, England. He wrote the first book-length history of Russian and Soviet homosexuality, *Homosexual Desire in Revolutionary Russia: The Regulation of Sexual and Gender Dissent* (University of Chicago Press, 2001), which was revised, expanded, and published in a Russian edition in 2008 by Ladomir Press, Moscow. Healey examined the early Soviet sexual revolution in his *Bolshevik Sexual Forensics: Diagnosing Disorder in the Clinic and Courtroom, 1917–1939* (Northern Illinois University Press, 2009). He is also the co-editor of essay collections on the history of Russian masculinity and on the history of Soviet medicine; and he continues to publish extensively on gender and sexuality in Russia. He is now writing a history of medicine in Soviet labour camps for Yale University Press, entitled *Gulag Hospital: The Paradox of Medical Care in Stalin's Forced-Labor Camps*.

Dagmar Herzog is Distinguished Professor of History and the Daniel Rose Faculty Scholar at the Graduate Center, City University of New York, where she teaches courses in Modern European history, the history of the Holocaust and its aftermath, interdisciplinary theory and research methodology, and the histories of gender and sexuality. At the Graduate Center, she has conducted extensive comparative and transnational research on how religion and secularization have affected social and political developments in modern Europe. She is the author of Sexuality in Europe: A Twentieth-Century History (Cambridge University Press, 2011), forthcoming also in Turkish; Sex in Crisis: The New Sexual Revolution and the Future of American Politics (Basic Books, 2008); Sex after Fascism: Memory and Morality in Twentieth-Century Germany (Princeton, 2005), which has been translated into German and Japanese; and Intimacy and Exclusion: Religious Politics in Pre-Revolutionary Baden (Princeton University Press, 1996; Transaction, 2007). She is the editor and coeditor of six anthologies, including, most recently, After the History of Sexuality: German Genealogies With and Beyond Foucault (Berghahn, 2012, with Helmut Puff and Scott Spector); Brutality and Desire: War and Sexuality in Europe's Twentieth Century (Palgrave Macmillan, 2009); and Lessons and Legacies VII: The Holocaust in International Perspective (Northwestern University Press, 2007). She serves as a member of the Board of Editors for the *American Historical Review* and is currently at work on two new projects: one on the intertwined vicissitudes of disability rights and reproductive rights in the European Union, and one on the politics of the European and American histories of psychoanalysis, trauma, and desire in the post-war era.

Mary Hilson is Senior Lecturer in Scandinavian History at University College London, and has previously worked at the universities of Uppsala and Helsinki. Her main research interests are in transnational social history, especially the history of the co-operative movement in the Nordic countries and beyond. Together with Silke Neunsinger she is also leading a project on the global history of consumer co-operation, 1800–2010.

Helen Parr is Lecturer in International Relations at Keele University. She is author of *Britain's Policy towards the European Community, 1964–7: Harold Wilson and Britain's World Role* (Routledge, 2006) and co-editor of *The Wilson Governments Reconsidered* (Routledge, 2006). She is currently working on the Parachute Regiment and the 1982 Falklands War.

Julia Roos is an Associate Professor of History at Indiana University, Bloomington, and author of *Weimar Through the Lens of Gender: Prostitution Reform, Woman's Emancipation, and German Democracy, 1919–1933* (University of Michigan Press, 2010). Her work on Weimar-era prostitution has appeared in multiple anthologies and journals, including the *Journal of the History of Sexuality* and *Central European History*. Her current research focuses on aspects of gender, nationalism and internationalism in the 1920s propaganda campaign against France's colonial occupation troops in the Rhineland (the socalled 'Black Horror on the Rhine'). Most recently, she has published 'Nationalism, Racism, and Propaganda in Early Weimar Germany: Contradictions in the Campaign against the ''Black Horror on the Rhine''', *German History*, 30, 1 (March 2012), 45–74.

Nadine Rossol is Lecturer in Modern European History at the University of Essex. Her publications include 'Ordinary Police Work? The Anti-Semitic Policy of Cologne's Police in the Third Reich', in G. Oram, ed., *Conflict and Legality: Policing Mid-Twentieth Century Europe* (Francis Boutle Publishers, 2003); 'Flaggenkrieg am Badestrand: Lokale Möglichkeiten repräsentativer Mitgestaltung in der Weimarer Republik', *Zeitschrift für Geschichtswissenschaft*, 7/8 (2008) and *Performing the Nation in Interwar Germany: Sport, Spectacle and Political Symbolism 1926–1936* (Palgrave, 2010). Having been supported by an Alexander von Humboldt Fellowship in the academic year 2011/2, Nadine is currently working on a project examining the German police as educators of the public (19205–1950s).

Jeffrey Weeks is Emeritus Professor of Sociology at London South Bank University (LSBU). He is the author of over twenty books, and more than 100 articles and papers, chiefly on the history and social organisation of sexuality, family and intimate life. His books include *Same Sex Intimacies: Families of Choice and Other Life Experiments* (with

Brian Heaphy and Catherine Donovan, Routledge, 2001), *The World We Have Won: The Remaking of Erotic and Intimate Life* (Routledge, 2007), *Sexuality* (3rd edn, Taylor & Francis, 2009) and *The Languages of Sexuality* (Routledge, 2011). A new edition of *Sex, Politics and Society: The Regulation of Sexuality since 1800* (1st edn, Longman, 1981) appeared with Pearson in 2012.





NOTES FOR CONTRIBUTORS

Contemporary European History covers the history of eastern and western Europe, including the United Kingdom, from 1918 to the present. By combining a wide geographical compass with a relatively short time span, the journal achieves both range and depth. It is open to all forms of historical enquiry – including cultural, economic, international, political and social approaches – and welcomes comparative and transnational analysis.

Submissions

Articles submitted for publication should be sent electronically to *Contemporary European History*, at ceh@sheffield.ac.uk, or, in the case of submissions from North America, to the Corresponding Editor for North America, Professor Amir Weiner, weiner@stanford.edu

Articles should normally be about 8,000 words long, the total to include footnotes. Review articles should not exceed 5,000 words.

The journal is published in English, and contributions are normally submitted in that language; however, we will also consider articles submitted in other major European languages. If accepted for publication, these will be translated. All articles, including those commissioned, will be refereed.

An abstract of each article is published in English, French and German.

Submission of a paper will be taken to imply that it is unpublished and is not being considered for publication elsewhere. On acceptance of a paper, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press. An article cannot be published unless a signed copyright form is returned promptly.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their text.

The editors would be grateful if contributors kept closely to the journal's stylistic conventions. Copy-editing is time-consuming and the editors will return any contribution which does not follow the conventions for correction and re-typing.

Contributors of accepted papers should send a final version via email. This should include

- 1. the text, which should begin with the title, the author's name and email and postal address, and the author's affiliation as he/she should wish it to appear
- 2. a 100-word summary of the article in English, French or German
- 3. a short title for use as a running page-head
- 4. a statement of the article's length in number of words (including both text and footnotes), and a list of tables, graphs, maps and any other illustrative material (each of which should be supplied as a separate file)
- 5. a short biographical note with a description of work in progress and previously published work (130 words max.)
