Authors of papers on Latin American topics are encouraged to submit their work to Latin American Antiquity. Papers on Latin American archaeology addressing broad methodological, theoretical, or comparative issues may be accepted by either journal after consultation with the editors. Authors submit manuscripts to the editor for consideration as ARTICLES, REPORTS, COMMENTS, or FORUM essays. REVIEWS and BOOK NOTES are solicited by the respective associate editors. Effective July 1, 1996, OBITUARIES may be submitted to the editor, SAA Bulletin, for publication (see SAA Bulletin March/April 1996, p. 7, for further details).

Authors should submit an original and four copies of their manuscripts, including all figures, tables, references, and notes. Detailed information on policy, style, and technical matters of manuscript preparation is given in the "Editorial Policy, Information for Authors, and Style Guide for *American Antiquity* and *Latin American Antiquity*," which appeared in the October 1992 issue (57:749–770) and can be read on the World Wide Web at http://www.saa.org/Publications/StyleGuide/styframe.html .
