## Memories of Loyang

Yang Hsüan-chih and the Lost Capital (493–534)

**W. J. F. Jenner**

In its forty-one years as the capital of North China from 493 to 534, the city of Loyang was created by imperial command on a deserted site, grew until it contained 1,367 Buddhist monasteries and nunneries and at least 500,000 inhabitants, and was compulsorily abandoned at three days' notice. This book is a study of the origins, history, functions, and nature of this remarkable city. It includes a translation of Yang Hsüan-chih's *Lo-yang ch'ieh-lan chi*, a graphic and lively guide-book for the memory written shortly after the city was destroyed, that is the earliest substantial account of a Chinese city to survive. £25

## Chinese Revolutionary

Memoirs 1919–1949

**Wang Fan-Hsi**

Wang Fan-Hsi, born in 1907, joined the Chinese Communist Party while a student in Peking during the 1920s, and after doing party work in Canton and Wuhan, was sent to Moscow for training. There he came under the influence of the Trotskyist opposition, and it was as an 'Oppositionist' that he returned to China to work in the underground Party apparatus in Shanghai. Expelled from the Party for his Trotskyist views, he spent most of the years from 1931 to 1937 in Kuomintang prisons, being released from solitary confinement just as the Japanese invaded. His career as an activist continued until the Trotskyists were purged after Mao's victory in 1949. Wang escaped to Macao where he wrote these memoirs, the only published account from a revolutionary's point of view of a still largely obscure period in Chinese history. £15
