NOTES ON THE CONTRIBUTORS

C. RICHARD BATH is Associate Professor of Political Science at the University of Texas at El Paso. He has spent several years of research in Bolivia and traveled widely in Latin America. Published journal articles include works on law of the sea and Mexican border affairs.

DILMUS D. JAMES is Associate Professor of Economics and Finance at the University of Texas at El Paso. He has authored a book and articles on various aspects of science and technology policy in developing countries.

WILBER A. CHAFFEE is Visiting Assistant Professor at the University of Texas at Austin. His other publications and research include both Latin America and Southeast Asia.
