**Trenton Akers** is a state political reporter at the *Courier-Mail* and *Sunday Mail*, who travelled on the 2017 Queensland state election campaign.

**Lee Butterworth** is a Research Fellow with the Harry Gentle Resource Centre, School of Humanities, Languages and Social Science at Griffith University. She is also a Research Associate with the Prosecution Project, School of Criminology and Criminal Justice at Griffith University. Lee's research interests focus on Queensland history, child welfare history and Australian coronial law and history.

**Lee Duffield** is a Research Associate at the Pacific Media Centre, Auckland University of Technology.

**Mark Finnane** is Professor of History at Griffith University. He has published widely in Australian and Irish history, with a particular focus on studies of institutionalisation, policing, punishment and the criminal law. Currently he is ARC Laureate Fellow, directing the Prosecution Projection, hosted in the Griffith Criminology Institute.

**Ameer Chasib Furaih** is a PhD candidate in the School of Languages, Humanities and Social Science at Griffith University. He received his Master's degree in modern American poetry from the University of Baghdad, College of Education (Ibn-Rushd) in 2008 and joined the English Department in 2010. His current research primarily investigates Australian Aboriginal and African American poetry of the Civil Rights Movement and beyond.

**Kerry Heckenberg** is an Honorary Research Fellow in the School of Communication and Arts at the University of Queensland. Her research deals with the making and reception of Australian art, particularly in the nineteenth and early twentieth centuries, focusing on the relationship between art and science. Her work has been published widely, with recent essays appearing in journals such as *Script and Print* (2012), the *Journal of Art Historiography* (2014) and *Australian Literary Studies* (2015).

**Jolanda Jetten** is Professor of Social Psychology at the University of Queensland. She won the Spearman Medal in 2004 and was inducted into the Academy of the Social Sciences in Australia in 2015. Her research is concerned with social identity, group processes and intergroup relations.

**Niels Kraaier** is an Adjunct Research Fellow with the Griffith Centre for Social and Cultural Research, specialising in government communication. He is also a foreign correspondent for media outlets in his native country, the Netherlands.

**Nathan Laurent** is a sessional academic in journalism, media and communication in the Creative Industries Faculty at Queensland University of Technology. In 2014, his research was supported by the Adrian Scott Scholarship for Research into Rural and Regional Journalism (QUT).

**Chris Leppard-Quinn** is an honorary researcher at the University of Tasmania and is employed on the Prosecution Project at Griffith University. She specialises in convict history, particularly female convicts who were identified as prostitutes, and the implications that label held for them during assignment and following servitude. Chris is currently examining the processes and purposes of record-keeping in the nineteenth century and the contemporary use and abuse of those records.

**Robert Mason** is a Senior Lecturer in the School of Humanities, Languages and Social Science at Griffith University. His research focuses on how contemporary societies experience and discuss historical violence. He is particularly interested in Spanish-speaking and Portuguese-speaking communities in Asia, Australia and North America.

**Frank Mols** is a Lecturer in Political Science at the University of Queensland. His research interests include populism, nationalism, political psychology, voter attitudes, EU attitudes, public policy analysis and behavioural economics.

**Kelly Palmer** lectures and tutors in popular culture, literary studies and writing at Queensland University of Technology. Her practice-led PhD looks to cultural and literary studies to explore how low-income locals practise belonging on the Gold Coast. She has recently published in *The Routledge Handbook of Popular Culture and Tourism*, *Transnational Literature* and *Voiceworks*.

**Peter Roennfeldt** is a former director of Queensland Conservatorium at Griffith University. He has published widely on Queensland's music. His monographs examine the history of the Queensland Conservatorium, the Brisbane Chorale and the career of Madame Mallalieu. Numerous articles also document historical aspects of Queensland's chamber music, performance venues and other significant musicians.

**Chris Salisbury** is a Research Associate in the School of Political Science and International Studies at the University of Queensland. He researches and writes on Queensland and Australian politics and government policy-making, and comments on state and federal politics to local and national media.

**Yorick Smaal** is a Senior Lecturer in History in the School of Humanities, Languages and Social Science at Griffith University. He has particular research interests in sex and gender, crime and punishment, and war and society, and has published widely in these areas. He is author of *Sex, Soldiers and the South Pacific, 1939–45: Queer Identities in Australia in the Second World War* (Palgrave Macmillan, 2015).

**Chrystopher J. Spicer** is the author of a number of books on Australian cultural history and American film history, including *Clark Gable: Biography* (2002), *Great Australian World Firsts* (2012) and *The Flying Adventures of Jessie Keith 'Chubbie' Miller* (2017). He currently teaches academic writing at James Cook University in Cairns while undertaking PhD research. His project investigates the cyclone as a trope of epiphany and apocalypse in Queensland literature. His most recent paper

is 'The Cyclone Which is at the Heart of Things: The Cyclone as Trope of Place and Apocalypse in Queensland Literature', *eTropic*, 15(2) (2016): 58–68.

**Pete Walsh** is currently enrolled in a Master of Arts at the University of Southern Queensland, due for completion in 2018. His thesis focuses on themes of transgression and body politics in transcultural writing. His academic interests include women's and migrant literature, and psychoanalytic and feminist criticism.

**Paul D. Williams** teaches politics and journalism in the School of Humanities, Languages and Social Science at Griffith University. He is a regular media commentator on Queensland state and Australian national politics.

## SUBMISSION INSTRUCTIONS

*Queensland Review* publishes articles of approximately 5000-6000 words. Please email submissions to *Queensland Review* to the Lead Editor, Dr Michael T. Davis, at: [m.davis@griffith.edu.au](mailto:m.davis@griffith.edu.au)

1. At least two separate files must be submitted. If there are figures, three or more separate files must be submitted.
  - i A Title Page document. The name of this file must be constructed as follows: [first 20 characters of the title]\_[ddmmyear]\_QR\_Title.doc
  - ii An Article document. The name of this file must be constructed as follows: [first 20 characters of the title]\_[ddmmyear]\_QR\_Article.doc
  - iii Any Figure documents should be supplied with the name of the file constructed as follows: [first 20 characters of the title]\_[ddmmyear]\_QR\_Figure# (with # being the number of the figure)
2. The Title Page and Article documents should be saved as Microsoft Word documents, in Times New Roman 12 pt font, double-spaced with margins of at least 25 mm on both sides and in A4 page size.
3. The Title Page document should contain the full title of the article as well as the full names and affiliations of all authors followed by full postal and email addresses for the corresponding author. A word count and suggested running head of no more than 50 characters including spaces should also be provided.
4. The Article document should include the complete article without any identifiable author details but including the title and an abstract not exceeding 200 words that provides a brief overview of the aims, method and major findings, without any citations. The abstract will not be published, but may be used for publicity purposes.
5. Tables should be created in Word and included at the end of the article after the references, with their approximate positions in the text indicated by the words, 'Insert Table X here'. Horizontal and vertical lines should be used sparingly.
6. Figures, graphs, illustrations and photographs (but not tables) should be prepared to the correct size and each one supplied as individual files, separate to the article. To ensure optimal quality, please follow the guidelines provided in the full instructions available at [cambridge.org/qre](http://cambridge.org/qre)

A list of figure captions should follow the tables in the article document. Captions must include sources

and permissions for copyright material. It is the responsibility of the corresponding author to obtain written permission to reproduce any photographs or other copyright material.

## REVIEW

All manuscripts are sent for blind peer-review to members of the editorial board and guest reviewers. The review process generally requires three months. The receipt of submitted manuscripts will be acknowledged by the editor, from whom a decision and reviewers' comments will be received when the peer-review has been completed. Papers submitted to the journal must not previously have been published, and must not be submitted for publication to any other journal while under consideration for *Queensland Review*.

## STYLE AND REFERENCING

For details of the *Queensland Review* style, please see the style and referencing guide available at [journals.cambridge.org/qre](http://journals.cambridge.org/qre)

1. Authors should follow Australian spelling and punctuation conventions throughout their articles (except in quotations from other sources, where the spelling convention of the original should be retained). Use the Oxford English Dictionary.
2. Use single inverted commas, except for quotations within quotations (which have double inverted commas). Punctuation should follow closing inverted commas except for grammatically complete sentences beginning with a capital.
3. Since *Queensland Review* is a multi-disciplinary journal, we accept referencing using either the short-title (endnote) system or the author-date (Harvard) system, depending on the disciplinary base on the author. Each individual paper must conform to one or other of these systems.
4. Use endnotes, not footnotes.
5. Include a bibliography only if the author-date (Harvard) system of referencing is used.
6. Generally notes should be kept brief. Source references should be given with as little additional matter as possible.
7. Quotations should be kept to a minimum and lengthy quotations should be avoided. As a general rule, quotations of more than about 60 words should be set off from the main text (indented with extra space above and below). Those of fewer than 60 words should run on in the text inside inverted commas.
