This monograph seeks to advance our understanding of the international law of negotiation and use this as a framework for assessing the Israeli–Palestinian dispute, with the Palestinian people's unsuccessful attempt to join the United Nations as a Member State in autumn 2011 and the successful attempt to join the same institution as a non-Member Observer State in November 2012 providing a case study for this. This work fills a significant gap in the existing international law scholarship on the Israeli-Palestinian dispute, which neither engages with this means of dispute settlement generally nor does so specifically within the context of the Palestinian people's engagements with international institutions.

Lawyers and Mediators

The Brave New World of Services for Separating Families Mavis Maclean and John Eekelaar

This book describes the structure of service provision and the day-to-day work of lawyers, mediators, and lawyer mediators, drawing on empirical work carried out between 2013 and 2015 immediately after the recent changes to the management of divorce and separation within the family justice system. The reduction in legal aided help in 2013 and the failure of mediation to fill the gap in 2014–15 have given rise to a difficult debate. This book aims to provide an account of some of the practical effects of these policies through a description of the daily work of practitioners in the sector.








World Trade Review



TEL strives to respect an expedient turn-around time of 6 – 8 weeks between receipt of the manuscript and first notification of acceptance, rejection or need for revision.

The length of manuscripts should normally range between 8,000 and 11,000 words (including footnotes) for full-length articles; 3,000 - 6,000 words for commentaries and case notes; and 800 - 1,500 words for book reviews. Exceptionally, shorter or longer works may be considered at the Editors' discretion.
