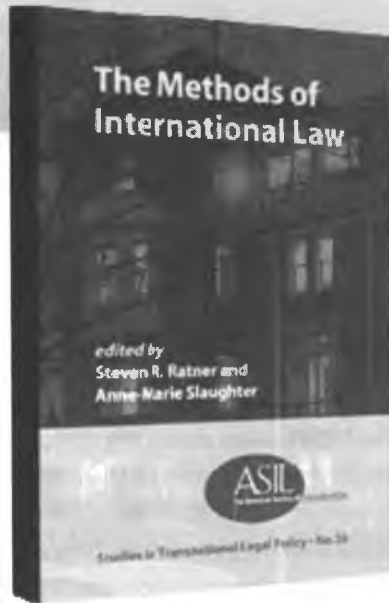

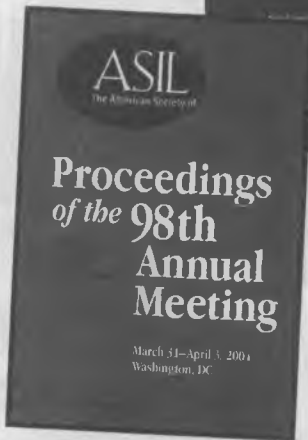

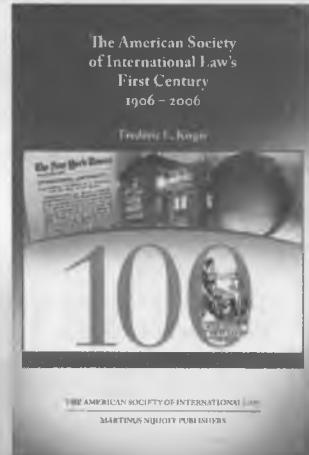


The American Society of International Law's First Century 1906 - 2006
