## CONTRIBUTORS TO THIS ISSUE

NICHOLAS TARLING, Professor of History at the University of Auckland, New Zealand, obtained his MA and PhD degrees from Cambridge University, England. He had published extensively on Malaysian history, and among his books are *British Policy in the Malay Peninsula and Archipelago, 1824–1871*, *Piracy and Politics in the Malay World*, and *Britain, the Brookes and Brunei*. He has just completed a manuscript entitled 'British Policy in Sulu and Sabah'.

ERNEST CHEW is Senior Lecturer in History at the University of Singapore, from which he received his MA degree for a thesis on 'Frank Swettenham's Malayan Career up to 1896'. He also holds a PhD in Indian history from Cambridge University. He has contributed several articles to journals, and is completing the revision of his two dissertations for publication. He is currently a Visiting Fellow at the Harvard-Yenching Institute, USA.

KHOO KAY KIM, Acting Head of the Department of History, University of Malaya, has contributed several papers on Malaysian history to academic journals. In 1971 he published his book on *The Western Malay States, 1850–1873*. His PhD thesis entitled 'The Beginnings of Political Extremism in Malaya' will soon appear as one of the Oxford University Press East Asia monographs.

J. H. DRABBLE, formerly a lecturer at the University of Malaya and now a Lecturer in Economic History at the University of Sydney, graduated with a MA degree from Cambridge University and a PhD degree from London University. His book called *Rubber in Malaya, 1876–1922: The Genesis of the Industry* was published by the Oxford University Press in 1973. He is currently doing research on the Malayan rubber industry during the years, 1922–42.

REX STEVENSON is First Secretary at the Australian Embassy, Bangkok. He is a former graduate of the Monash University Centre of Southeast Asian Studies. His study 'British Educational Policy Towards the Malays, 1875–1906' will be published by Oxford University Press, Kuala Lumpur, later this year.

PHILIP LOH FOOK-SENG, a PhD Stanford University graduate, is Associate Professor in Education at the University of Malaya. His MA thesis entitled *The Malay States, 1877–1895: Political Change and Social Policy* has been published by the Oxford University Press in 1969. He is currently doing research on the social and political attitudes of Sixth Formers in Malaysian schools.

C. M. TURNBULL, a PhD London University graduate, is Senior Lecturer in History at the University of Hong Kong. Her best-known book is entitled *The Straits Settlements, 1824–67*. She has completed a manuscript on 'A History of Modern Singapore, 1819–1973'.

JAMES P. ONGKILI is Lecturer in History at the University of Malaya, and has recently completed a research fellowship with the Institute of Southeast Asian Studies, Singapore, where he did the writing-up of his PhD thesis on 'Nationalism in Malaya, 1946–1973'. He is the author of *Susuzan Totopot do Sabah (History of Sabah)*; *The Borneo Response to Malaysia, 1961–1963*; and *Modernization in East Malaysia, 1960–1970*.
