The illustration depicts the final assembly plant for the front wheel drive car, built by Citroën in 1933 on the site of its previous plant. As the cars moved off the line toward the Seine, the best viewpoint was offered by André Citroën's balcony office, located exactly at the center on the second floor. The building was really a huge exhibition hall for the assembly line where the chassis converged for the final operations. The open, high-ceilinged, well-lighted, and generous space was an essential component of the display. Citroën wanted his factory to be the symbol of modern and americanized automobile production, a factory—and a car, the Traction Avant—worthy of Paris and the automobile era.

# CONTRIBUTORS

Yves Cohen is a research fellow at the Centre de recherche en histoire des sciences et des techniques in Paris. He has written several articles on the development of the French automobile industry, including "L'espace de l'organisateur: Ernest Mattern, 1906–1939," Le mouvement social (1983), and a study with Olivier Cinqualbre, Les usines dans l'action d'un grand industriel: André Citroën, quai de Javel (1984). In Spring 1991 he was a visiting scholar at the Minda de Gunzburg Center for European Studies at Harvard University.

Susan Helper, who holds a Ph.D. in economics from Harvard University, is assistant professor of economics and a research associate at the Center for Regional Economic Issues, Case Western Reserve University. She previously taught Operations Management at Boston University. Her research interests include changing supplier relations (particularly in the auto industry) and the effectiveness of interfirm networks in improving economic performance, in both the United States and Mexico. Much of her automotive research is carried out in collaboration with the International Motor Vehicle Program at the Massachusetts Institute of Technology. She has published in journals including the Sloan Management Review and the Journal of Law, Economics and Organization.

Roland Marchand is professor of history at the University of California, Davis. He received his Ph.D. in History and Humanities from Stanford University. He is the author of Advertising the American Dream (1985) and of several recent articles on the design of corporate exhibits at world's fairs (in Design Issues) and on corporate public relations. He is currently working on a history of corporate imagery and corporate public relations in the United States during the first half of the twentieth century.

Daniel M. G. Raff is visiting associate professor of business administration at Columbia University, on leave from the Harvard Business School. He is a Faculty Research Fellow of the National Bureau of Economic Research and one of the co-organizers of the NBER economic and business history conferences. His principal current research concerns American manufacturing during the Great Depression. He is also interested in the evolution of firm capabilities, competitive practices, and industrial organization in retailing and finance.

Helen Shapiro received her doctorate in economics from Yale University in 1988. She is an assistant professor of business administration at the Harvard Business School. Her dissertation was awarded the 1989 Herman E. Krooss Prize of the Business History Conference; a revised version, Engines of Growth: The State and Transnational Auto Companies in Brazil, will be published by Cambridge University Press. She has recently completed a study on investment and trade flows in the Brazilian and Mexican auto industries, "Automobiles: From Import Substitution to Export Promotion in Brazil and Mexico," in a larger Harvard Business School project on world trade and global competition, to be published as Beyond Free Trade: Firms and Governments in World Trade, ed. David B. Yoffie, forthcoming from Harvard Business School Press in 1993.
