In the first political analysis of unemployment in a socialist country, Susan Woodward argues that the bloody conflicts that are destroying Yugoslavia stem not so much from ancient ethnic hatreds as from the political and social divisions created by a failed socialist program to prevent capitalist joblessness.

By 1985, Yugoslavia's unemployment rate had risen to 15 percent. How was it that a labor-oriented government managed to tolerate so clear a violation of the socialist commitment to full employment? Proposing a politically based model to explain this paradox, Woodward analyzes the ideology of economic growth. She argues that unemployment became politically "invisible," with the result that it corrupted and ultimately dissolved the authority of all political institutions.

# Supplementary Empirical Teaching Units in Political Science

are widely used in political science courses. A SETUPS includes a monograph and dataset. Now this new SETUPS includes data from six presidential elections, 1972-1992. The data are from the American National Election Study Cumulative Data File. The dataset includes 70 variables, most of which were asked in each of the six years, and all of which are available for at least the majority of the years. All the respondents interviewed in the six ANES surveys are included. A monograph, similar to those for past SETUPS, accompanies the dataset. This SETUPS makes it possible to analyze voting behavior over a series of elections as well as within a single election. This feature is covered in the discussions and exercises in the monograph.

The dataset for this SETUPS is available from the ICPSR in a format suitable for use either on mainframe or microcomputers. Several files will be provided: (a) an SPSS export file; (b) a raw data file; (c) SPSS file definition statements; and (d) SAS file definition statements. This SETUPS is especially designed for use with SPSS, as the monograph uses SPSS commands as examples. Users of either SPSS for Windows or a mainframe version of SPSS should find the SPSS export file the most convenient to use, but the raw data and file definition statements also are provided as a backup choice. SAS users can either use the raw data and SAS file definition statements or can import the SPSS system file through the SPSS/SAS interface.
